Adverting to the subject and references cited above, it is submitted that, Government of India, Ministry of Environment, Forests & Climate change, Chennai vide reference 1st cited has accorded in-principle (Stage-I) approval for diversion of 2.0401 Ha. Forest Land in Gannegutta RF in Jagtial District for construction of 400 KV QMDC line from STPP Jaipuram in Adilabad District to 400 KVSS, Nirmal, Nirmal District in favour of Superintending Engineer, 400 KV Construction Circle, TRANSCO, Karimnagar (User Agency) which has been communicated by the Prl.CCF, T.S., Hyderabad vide reference 2nd cited with instructions to raise demand notice over User Agency in consultation with the Nodal Officer, FCA for payment of compensatory levies like Compensatory Afforestation as per the (C.No.3,4); Penal CA (PCA) (C.No.6); Penal NPV (C.No.7); Net Present Value (NPV) (C.No.8); cost of plantation of dwarf species in the ROW under transmission line (C.No.11); demarcation of forest land (C.No.2); etc. by User Agency and to obtain the compliance report on the conditions stipulated by the MoEF&CC, Gol, from the User Agency and furnish the same for obtaining the Stage II (final) approval.

Accordingly, the following are the amounts estimated for payment of compensatory levies and submitted to the Nodal Officer FCA for vetting and the same has been approved.



As per the conditions stipulated in Stage-I approval, the User Agency has to make the payment of the following Compensatory Levies into the accounts indicated:

The User Agency has to deposit an amount of Rs. 1,49,37,824/- (Rupees One Crore Fourty Nine Lakhs Thirty Seven thousands Eight hundred and Twenty Four only) in the State Compensatory Afforestation Fund of Telangana State through online.

Further the User Agency has requested to deposit an amount of Rs.2,35,500 /- (Rupees Two Lakhs Thirty Five thousands Five hundred only) towards construction of boundary pillars and extraction of tree growth in to CA PD account of DFO, Jagtial bearing number 025810100294226, UBI, Tahsil Chourastha Branch: Jagtial, IFSC Code: UBIN0802581.

Further, the User Agency will be directed to install the bird reflectors, fixed on upper conductor of transmission line at suitable intervals to avoid bird hits.

It is further submitted that, the User Agency is requested to upload the Demand Notice at Ministry's portal i.e., http://parivesh.nic.in/ against the project for verification and acceptance of demand notice by the Nodal Officer, FCA for accepting the demand online in the forest clearance portal. After accepting the demand notice by the Nodal Officer, the User Agency shall generate e-challan and deposit the funds into the Telengana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) account of Telangana against the Challan number. The step-by-step process involved is available at Ministry's portal.

Further, the User Agency has to comply with following in accordance with the MoEF&CC, Gol instructions issued vide F.no.7-23-2012-FC, Dt.24.07.2013 communicated vide Prl. Chief Conservator of Forests, A.P. Hyderabad Rc.No.45921/2001/F4, Dt.23.08.2013:

- 1. Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central government in two widely circulated daily newspaper one is vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
- 2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

Further, the User Agency has to furnish the compliance on the conditions stipulated in the Stage I (in-principle) approval for onward submission to Government for obtaining Stage-II (final) approval.

The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval or working permission.
