NAME AND POST OFFICE ADDRESS OF THE PARTY OF

The User Agency, Jio Digital Fibre Private Limited, Chennai has uploaded a proposal (FP/TN/OFC/119342/2021) in PARIVESH portal for diversion of 0.0107 ha. of forest land for laying of underground Optical Fibre Cable along Sokkanathapuram to Maravamadurai route through forest areas in Ammankurichi Reserved Forest in Pudukkottai District for a period of 100 years under section 2(1) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980.

- 2. The District Forest Officer, Pudukkottai Division in the reference second cited and the Chief Conservator of Forests, Trichy Circle in the reference third cited have recommended the above said proposal and forwarded Site Inspection report of the Project area. Based on the recommendations made by the District Forest Officer, Pudukkottai Division and Chief Conservator of Forests, Trichy Circle, the Principal Chief Conservator of Forests (FCA) / Nodal Officer has recommended the above said proposal in the Part–IV, Form–A in Parivesh 1.0 portal and the Principal Chief Conservator of Forests (HoFF) has forwarded the same to Government for its consideration and requested to obtain approval from the Regional office, Government of India for a period of 20 years.
- 3. The Government have examined the proposal in detail (copy enclosed) and decided to recommend the proposal (FP/TN/OFC/119342/2021) for diversion of 0.0107 ha. of forest land for laying of underground Optical Fibre Cable along Sokkanathapuram to Maravamadurai route through forest areas in Ammankurichi Reserved Forest in Pudukkottai District in favour of Jio Digital Fibre Private Limited, Chennai for a period of 20 years under section 2 (1) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and forward it to Regional office, Government of India, Ministry of Environment, Forests and Climate Change, Chennai for obtaining their concurrence subject to the following conditions:-
  - (i) The legal status of the diverted forest land shall remain as unchanged and shall remain as Reserved Forest.
  - (ii) Demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars, duly numbered at appropriate places as per the directions of the District Forest Officer concerned at the cost of User Agency.
  - (iii) The pipeline shall be laid down 1.5m below the ground and after laying down of Optical Fibre Cable the ground should be leveled.
  - (iv) The User Agency has to pay the cost of raising Compensatory Afforestation / maintenance of plantation, etc as fixed by the Forest Department.
  - (v) Amount for Compensatory afforestation scheme under the project shall be transferred / deposited to CAMPA fund only through e-portal (<a href="https://parivesh.nic.in/">https://parivesh.nic.in/</a>).
  - (vi) The amount of Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to the effect.
  - (vii) The User Agency shall be responsible for any loss to Flora and Fauna in the surroundings and shall take all possible measures to conserve the same.
  - (viii) The forest land shall not be used for any purpose other than that specified in the proposal.
  - (ix) The layout plan of the proposal shall not be changed without the prior approval.
  - (x) No labour camp shall be established on the forest land.
  - (xi) Disturbance shall be kept minimal by creating labour camps outside the forest area as far as possible and it will be the responsibility of the user agency to ensure that the machinery, labourers and staff engaged in execution of work shall not destruct nearby forest flora and fauna.

(xii) The forest land proposed for diversion shall under no circumstances be transferred or sublet to any other agency, department or person without prior approval of the competent authority.

(xiii) The user agency shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines for the time being in force,

as applicable to the Project.

(xiv) In the event of failure to comply with any of the above conditions, the user agency is liable for penal action as per the provisions of the Ministry of Environment, Forests and Climate Change guidelines.

The total forest area utilized for the project shall not exceed

0.0107 ha area in Ammankurichi Reserved Forest.

- (xvi) The lease rent should be realized from the User Agency as per G.O.(Ms.)No.272, Environment and Forests (FR.XIII) Department, dated 15.04.1991.
- (xvii) The Chief Conservator of Forests and District Forest Officer may impose any other condition in the interest of conservation / protection and development of forests.

(xviii) Period of lease is twenty (20) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State

Forest Department.

(xix) The compliance report shall be uploaded on e-portal.

4. I am, therefore, directed to request you to kindly obtain the concurrence of the Competent Authority and communicate the same to this Government, early.

I wish to state that the Jio Digital Fibre private Ltd., Chennai has sent a proposal under Section 2 of Forest (Conservation) Act, 1980 for diversion of 0.0107 ha of forest land for laying of underground OFC along Sokkanathapuram to Maravamadurai route through forest areas of Ammankurichi Reserved Forest in Pudukkottai District through online web portal in the prescribed format.

- 2) The User Agency has furnished following Certificates / Undertakings.
- i. Signed copy of Form A.
- ii. Letter of Authorisation.
- iii. GPS map of the proposed water supply pipelines through Ammankurichi Reserved Forest
- iv. Survey of India topo sheet indicating boundary of forest land proposed.
- v. Google map for the Forest land proposed for diversion in Ammankurichi RF.
- vi. Justification for locating the project in Forest land
- vii. Certificate of Settlement of rights under Scheduled Tribes and Other Traditional Forest Dwellers under Forest Rights Act 2006 in the prescribed format obtained from the District Collector, Pudukkottai in ROC No.E4/2718/2021 dt.15.06.2022.
- viii) Certificate from the District Collector regarding no other feasibility alternate alignment for the above project obtained from the District Collector, Pudukottai vide ROC.No.E4/2718/2021 dt.15.06.2022.
  - 3) In Additional information details the following documents were uploaded.

- b) Certificate by the user Agency that there is no CAT plan in the approved plan.

- e)Under taking by the user agency to bear the cost of Compensatory Afforestation / Penal Compensatory Afforestation / Maintenance of plantation/ Protection of plantation if any for the proposed Diversion of Forest land fixed by the Forest Department.
- f) Under taking by the user agency for the payment of Net Present Value of the forest land involved.
- j) Undertaking by the user agency for the payment of Additional Net Present Value if any demand raised by the forest department.
- h) Undertaking to pay the cost along with any escalation for exploitation of trees if any available in the alignment path any for the proposed Diversion of Forest land fixed by the Forest Department.

  - 4) The District Forest Officer, Pudukkottai has uploaded the Part-II of Form A and furnished the details as noted below.:
  - i) Area to be diverted for the above proposal is 0.0107ha forest land in Ammankurichy Reserved Forest to a density of zero and type of forest is Eco class-4.
  - ii) No spontaneous or planted tree growth is available in the proposed forest area.
  - iii) The details of wildlife present in and around the forest land proposed for diversion is Spotted deer, Peacock, python, monkey and hare.
  - iv) The proposed area does not forms part of National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve, Elephant Corridor, Wildlife Migration Corridor.
  - v) The proposed area is not located within Eco Sensitive Zone of the protected area notified under Wildlife (Protection) Act 1972.
  - vi) The forest land proposed for diversion is not located within 1km from the boundary of National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve, Elephant Corridor, and Wildlife Migration Corridor.
  - vii) No rare / endangered / unique species of Flora and Fauna found in the proposed area.
  - viii) No protected archeological / heritage site / defense establishment or any other important monument is located in the area.

- ix) No work in violation of the Act or guidelines issued under the act.
- x) No Compensatory Afforestation, has been proposed as no felling of trees involved in this project.
- 5) The District Forest Officer, Pudukkottai has inspected the proposed project site in Ammankurichi Reserved Forest on 15.12.2022 and stated that
- a) The length of the OFC to be laid is 357m to a width of 0.30m to a depth of 1 to 2m and the area proposed is 0.0107ha.
- b) The cable will be laid on the right side of the road from Sokkanathapuram to Maravamadurai across Ammankurichi Reserved Forest.
- d. The user agency has informed that no trees or vegetation will be felled or disturbed during the execution of the project.
- e. About machinery to be used for excavation and its impact, the user agency has informed that earthmover will be used without disturbing the vegetation and the excavated earth will be dumped on the road side and not on the forest side.
- The project is important for better connectivity of 4G net work to all the public for communication.
  - (g) The user agency has informed that the excavation will be immediately closed after laying the underground OFC without affecting the migratory wildlife.
    - 6) In the recommendation, the District Forest Officer has stated that since the work is essential for improvement of better communication infrastructure (4G network) to all the people and the project does not involve felling of trees and other vegetation, it is recommended.
    - 7) The Chief Conservator of Forests, Trichy in his site inspection report stated that (i). The proposed area for diversion of 0.0107ha in Ammankurichi Reserved Forest in Pudukkottai District has been inspected along with District Forest Officer, Pudukkottai on 29.12.2022.
    - ii). The project is important for better connectivity of 4G net work to all the public for communication.
    - iii) The user agency has informed that no trees or vegetation will be felled or disturbed during the execution of the project.
    - (iv) The user agency has informed that the excavation will be immediately closed after laying the underground OFC without affecting the migratory wildlife.
    - (v) There is no alternate land is available.
    - 8) In the recommendation, the Chief Conservator of Forests, Trichy has stated that the proposal for diversion of 0.0107ha of forest land for laying of underground OFC in Chokkanathapuram to Maravamadurai across Ammankurichi Reserved Forest for providing 4G

wireless broadband at Pudukkotttai Division is recommended since no alternative land is available.

- 9) In this regard, it is submitted that the User Agency has uploaded all the certificates /undertakings/details as required in this proposal.
- 10) The proposal is sent herewith duly recommended in the part IV of Form A by the Additional Principal Chief Conservator of Forests (FCA) / Nodal Officer (Forest Conservation Act).
- 12) The area proposed for diversion of 0.0107ha of forest land for laying of underground OFC in Chokkanathapuram to Maravamadurai across Ammankurichi Reserved Forest for providing 4G wireless broadband at Pudukkotttai Division is recommended and forwarded to the State Government for consideration and to obtain approval from Government of India as the User Agency is a private company subject to the following conditions.
  - (i) The legal status of the land shall remain unchanged and shall remain as Reserved Forests.
  - (ii) The demarcation of the proposed forest area shall be carried out by erecting 4 feet height cement concrete pillars duly numbered at appropriate places as per the directions as the District Forest Officer concerned at the cost of User Agency.
  - (iii)The pipeline shall be laid down 1.5mbelow the ground and after laying down of OFC the ground should be leveled.
  - (iv)The Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future shall by charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to the effect.
  - (v)The User Agency shall be responsible for any loss to Flora and Fauna in the surroundings and shall take all possible measures to conserve the same.
  - (vi)The forest land shall not be used for any other purpose other than that specified in the proposal.
  - (vii)The lease rent should be realized from the User Agency as per G.O.Ms.No.272, E&F(FR.XIII) Dept. dated 15.04.1991.
  - (viii)The period of lease is 20 years.
  - (ix) The User Agency should send renewal proposal one year before expiry of lease.
  - (x)The Chief Conservator of Forests and District Forest Officer may impose any other condition in the interest of conservation /protection land development of forests.
  - (xi)The compliance report shall be uploaded on e-portal.

The Government of India Guidelines of Forest (Conservation) Act, 1980 in F.No.5-3/2007-FC, dated 05.02.2009, exemption for payment of Net Present Value for underground laying of Optical Fibre Cable has been allowed, if the area does not form a part of National Park / Sanctuary and no felling of trees is involved.

This project area is not declared as National Park / Sanctuary and no felling of trees involved in this project. Hence payment of Net Present Value for the forest area diversion of laying OFC may not be insisted.




