## **MEMORANDUM:-**

This department has given an "in principle" approval for Diversion of **0.04324 ha.** Protected Forest land for laying 4" dia steel gas pipeline connectivity to Kanubhai Rabari SGL CNG Station, Dehgam Taluka Dehgam Dist. Gandhinagar in favour of Chief Manager (TS&P), Sabarmati Gas Ltd., Gandhinagar vide letter referred at Sr. No.(1) above.

The Nodal Officer (FCA), Gujarat has reported that the User Agency has deposited an amount of Rs.41,415/- through NEFT/RTGS, dt.14.06.2022 towards the cost of NPV in Adhoc CAMPA, New Delhi by NEFT/RTGS(Challan) referred at Sr. No. (2) above.

The undersigned is pleased to convey the formal approval of the Government under section 2 of the Forest (Conservation) Act, 1980, subject to the following conditions:-

- 1. This permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
- 2. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
- 3. User Agency will have to obtain permission from the Nodal Officer (FCA), for carrying out any maintenance works in future except emergencies.
- 4. User Agency will have to restore the forest land after use/ maintenance work. No tree shall be cut.
- 5. User Agency will be liable to compensate any loss to Forests / Environment caused due to the use of the said land by the user agency.
- 6. User agency will seek permission from the Roads & Buildings Department/Science and Technology Department, Sachivalaya, Gandhinagar, if required so.
- 7. Gas Pipeline will be laid underground in the trench of maximum depth of 2.00 meters and width of 0.4 meters, in between rows of road side plantation.
- 8. Any other condition, which the Nodal officer (FCA) and State Government may stipulate from time to time.
