**Demand Notice to be issued after Stage-I approval  
Demand Notice under FCA 1980**

**Proposal No: FP/KA/WATER/150851/2022**

Government of India vide his letter dated: 02-09-2025 have issued 'in-principle' Stage-I approval for Renewal of diversion of 3.846 ha. of forest land in Block No: 10 of Navagadda F.Sy.No: 16A1A Ankola taluka, Binaga, Sy.No: 1376 of Baad Village, Karwar Taluka, Karwar Forest Division, Uttar Kannada District for construction of GLSR filter and tunnels under combined water supply scheme in favour of Karnataka Urban Water supply & Drainage Board (KUWSD&B), Kajubag, Karwar subject to conditions of approval mentioned therein. The same has been communicated to you and this office for issuing 'demand notice' and submission of a 'Compliance Report'. Accordingly, you are requested to make the payments shown hereunder. Further, it may also be noted that this in-principle approval shall be valid for a period of 2 years from the date of issue of Government of India's letter. In the event of non-compliance of the above conditions within 2 years, the principle approval shall be deemed to be null and void.


**General Conditions**

1. Legal status of the diverted forest land shall remain unchanged.
2. The boundary of the forest land to be diverted shall be suitably demarcated on ground at the project cost as per the directions of concerned Divisional Forest Officer before Stage-II approval.
3. Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the user agency. The user agency shall furnish an undertaking to this effect.

4. The User agency shall furnish an undertaking to provide CA land to compensate forest land being diverted by giving equal extent of Non Forest land and cost of raising CA, if determined, by Hon'ble Supreme Court /MoI:F&CC.
5. The KML file of the forest area to be diverted and CA area shall be uploaded on the e-green watch portal with all requisite details and GPS ids of the E-Green watch portal shall be submitted along with the compliance report.
6. The layout plan of the proposal shall not be changed without prior approval of Central Government.
7. No labour camp shall be established on the forest land.
8. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
9. The forest area shall be used for the purpose for which it is granted. The total forest area utilized for the project shall not exceed 3.846 ha.
10. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, Department or person without prior approval of Government of India.
11. The period of diversion under this approval shall be co-terminus with the project life.
12. The concerned Divisional Forest Officer, will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forest in the surrounding area
13. The compliance report shall be uploaded on e-portal (<https://parivesh.nic.in/>).
14. The user agency shall comply with all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT order, as applicable to the project.
15. The State Govt. shall ensure that the complete compliance of FRA 2006 as per the rule 11 (7) of Van (Sanrakshan Evarn Samvardhan) Rules 2023.
16. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evarn Samvardhan) Adhiniyam, 1980 and action would be taken as prescribed under the Act, Rules and Guidelines relevant. Any other condition that the Ministry of Environment, Forest and Climate Change may stipulate from time to time in the interest of conservation, protection and development of Forest and Wildlife.

**Procedure payment:** This Demand Notice is to be uploaded on FC web portal ([www.parivesh.nic.in](http://www.parivesh.nic.in)) for acceptance by the Nodal Officer. After acceptance by the Nodal Officer, a challan should be generated from the web portal for payment to the account mentioned in the challan. The Transaction details should be quoted by the User Agency in the condition-wise 'Compliance Report' submitted through Range Forest Officer, Ankola and Karwar for Stage-II approval. Payment made by any mode than that mentioned above will not be considered as compliance.
