I enclose herewith a copy of the letter cited along with statutory proforma proposal under Forest (Conservation) Act, 1980, submitted by the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh for diversion of 4.71 ha of forest land in compartment Nos.402, 403, 404 & 406 of Kankanapalli RF, Vizianagaram Division for providing BT to the road from National Highway-26 at 474/6 to Karadavalasa via Malamamidivalasa in favour of Executive Engineer, PR(PIU), Vizianagaram.

2. I am to inform that the User Agency i.e. Executive Engineer, PR(PIU), Vizianagaram, has furnished justification stating that the villagers of Roddavalasa, Ajuru, Kumbivalasa and Karadavalasa can reach the Mandal head quarters Saluru and Pachipenta with shortest path by providing this road. The existing road passes through Reserve Forest in various reaches in the road from 0/0 to 7/300 km. This is the only shortest route for the people of above habitations. The buses and commercial vehicles are not plying on this road due to improper geometry and various streams crossing the road. The people are facing lot of problems to meet their needs of Education, Health and Transportation of Agricultural and forest produces etc. Hence, the road is proposed to upgrade to the BT surface, so as to make the road traffic worthy. The requirement of forest land is un-avoidable and barest minimum for the project. The User Agency has identified non-forest land over an extent of 4.72 ha in Sy.No.279 of Gottivalasa (V), Garugubilli (M), Vizianagaram District for CA purpose. The District Forest Officer, Vizianagaram has prepared CA scheme to an extent of 4.72 ha for raising Compensatory Afforestation with a financial outlay of Rs.20.945 lakh for a period of 12 years commencing from 2022-23 to 2033-34 with 10 years of maintenance. The User Agency has furnished undertakings for payment of NPV, Addl. NPV, CA and tree extraction charges etc. The District Collector, Vizianagaram District has issued necessary certificates under Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006. The proposal has been uploaded in the Ministry's website and unique file No.FP/AP/ROAD/141400/2021 has been generated for this proposal. The concerned District Forest Officer, the Conservator of Forests and the Principal Chief Conservator of Forests & Head of Forest Force, have recommended the proforma proposal in Part-II, III and IV respectively. The recommendation of the State Government in proforma proposal in Part-V is enclosed herewith.

3. I request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forest & Climate Change, under Section-2 of Forest (Conservation) Act, 1980, for diversion of 4.71 ha of forest land in compartment Nos.402, 403, 404 & 406 of Kankanapalli RF, Vizianagaram Division for providing BT to the road from National Highway-26 at 474/6 to Karadavalasa via Malamamidivalasa in favour of Executive Engineer, PR(PIU), Vizianagaram, at an early date.
