- I am to inform that the User Agency i.e. Deputy Chief Engineer, Construction, Guntakal Division, South Central Railway, has furnished justification stating that as there is no alternative route to the Railway line, the forest land to an extent of 1.36 ha in Compartment no.238 & 239 of North Dhone RF, Dhone Beat, Dhone Range, Kurnool Division is required to construct the new double line and electrification of track between Guntur and Guntakal stations at Dhone (Rly km 325/4 to 329/2. The User Agency has furnished undertakings to bear the cost of raising and maintenance of compensatory afforestation, payment of NPV and addl.NPV, and cost of tree extraction charges. The District Collector, Kurnool District has issued necessary certificates under Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006. and Ministry's website in the uploaded has been The proposal No.FP/AP/RAIL/149334/2021 has been generated for this proposal. The concerned District Forest Officer, the Conservator of Forests and the Principal Chief Conservator of Forests & Head of Forest Force, have recommended the proforma proposal in Part-II, III and IV respectively. The recommendation of the State Government in proforma proposal in Part-V is enclosed herewith.
