It is to inform that, the Stage-I approval is accorded by the GOI for Diversion of 5.27 ha(revised to 3.99 ha) in compartment no.395& 396 of Bolagonda RF and compartment.750 of Tadepalli PF, of Foulkspeta Range of Rampachodavaram Division for formation of road from Pandirimamidi to Chavitidibbalu in favour of EE, R&B Division, Rajamahendravaram. The Principal Chief Conservator of Forests, Andhra Pradesh, Guntur issued instructions vide reference 2<sup>nd</sup> cited, for collection of the Net Present Value amount.

Further, it is to inform that, the Net Present Value is to be deposited for diversion of forest land for non forestry purpose, as per Hon'ble Supreme Court of India orders, dated: 28-03-2008 and 09-05-2008 and as per the orders issued by the Govt of AP vide GO.Ms.No.124; EFS&T(For.i) dept; Dt: 27-07-2010 and as per the Hand book of guidelines issued of Forest Conservation Act, 1980 communicated by GOI, MoEF & CC (FC Division) vide F.No.5-2/2017-FC; Dt: 28-03-2019.



In this connection, it is to inform that, as per the report of the FRO, Foulkspeta vide reference 3<sup>rd</sup> cited, the proposed forest area, which is to be diverted for formation of road from Pandirimamidi to Chavitidibbalu in favour of EE, R&B Division, Rajamahendravarm, is classified as **Eco class-III** and the density of the adjoining forests of the proposed area is **Open Forest**.

In this connection, the following amounts are to be deposited to the Adhoc CAMPA Account. The details are as follows.

**1. Amount demanded to be deposited in Adhoc CAMPA Corporation Bank, Lodhi Road, New Delhi through e-challan only.**

**1. (a) Procedure for e-challan generation:**

1. On issue of this demand notice, the user agency shall log in to Forest Clearance portal forestclearance.nic.in to generate e-challan and make payment against the demand.
2. Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
3. Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

**1. (b) Procedure for Payment through RTGS:**

4. For payment through RTGS the representative of the agency should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed e-challan with an Account Number printed on it.




5. While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
6. Upon executing the RTGS by the sender/remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.
2. Amount demanded for tree extraction, logging and transportation in the forest area diverted to be deposited with Divisional Forest Officer (As per IGF, Adhoc CAMPA Ir.no.13-20/2015-CAMPA; Dt:09-06-2016 communicated vide PCCF's Rc.No.45921/2001/FCA-4 (ii); Dated: 04-07-2016.).
