It is to inform that vide reference 1<sup>st</sup> cited, the undersigned has issued a demand notice to the user agency as per (Stage - I) guideline issued by the Government of India, and also requested to submit condition wise compliance report to this office on subject cited project. **1(a) Procedure for e-challan generation:**

- On issue of this demand notice, the User Agency shall log in to Forest clearance portal forest clearance in to generate e-challan and make payment against the demand.
- User Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

**1(b) Procedure for payment through RTGS:**

- For payment through RTGS, the representative of the agency should visit his branch (RTGS enabled) of a bank of his choice along with printed e-challan with an account number printed on it.
- While tending the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- Upon executing the RTGS by the sender/remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.

Moreover, the levies pertaining to mitigation plan shall be deposited by the user agency in Wildlife Conservation Projects & CSR (WLC & CSR) for implementation of mitigation plan in V P South Range of PT, Markapur. The details are as follows.

1. Publish the entire forest clearance granted in variation along with the condition and safe guards impose by the Central Government in two widely circulated daily news papers one in vernacular language and another in English language so as to make people aware of the permission granted to the project proponents for use of forest land for non forestry purpose.
2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayath's, and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

3. The User Agency is requested to deposit the above said amounts as early as possible for further course of action.
