

3. Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the central government in two widely circulated daily newspaper one in vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
4. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and Municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.


In view of the above, the user agency is requested to deposit the above said amount and submit the compliance report for onward transmission to Government of India after depositing the amount into designated above mention account to get final approval of this project.


