It is to inform that, vide references 2nd cited, the Government of Andhra Pradesh has issued In – Principal (Stage – I) approval accorded subject to the conditions stipulated under Section '2' of the Van (Sanrakshan Evam Samvardhan) Adhiniyam 1980 on subject cited project and the same is communicated by the Prl. Chief Conservator of Forests & Head of Forest Force, AP, Mangalagiri and the Conservator of Forests & Field Director, Project Tiger Circle, Nadyal vide reference 3rd & 4th cited...

Further, it is to inform that, as per revised rates of GoI, New Delhi F.No.5-3/2011-FC (Vol - I), dt.06.01.2022 guidelines issued by the Government of India. Accordingly, the undersigned has prepared all the levies to be deposited by the user agency and the same is submitted to the Field Director, Project Tiger Circle, Nadyal for approval vide reference 7^{th} cited.

Later, vide reference 8th cited, the Conservator of Forests & Field Director, Project Tiger Circle, Nandyal has approved the following levies and also issued an administrative sanction of CA Scheme in this regard. The details of all the levies are furnished hereunder.

Note:- The user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India in future, if any.

Further, it is to submit that, the Government of Andhra Pradesh has mentioned the following condition No IV In – Principal (Stage – I) approval accorded on subject cited project.

"The state Forest Department shall carry out Compensatory Afforestation over an extent of 1.00 ha of degraded forest land identified in Compt No.175, ENB – X RF, Komarolu Beat, Y Palem Section, Y Palem Range of PT, Markapur at the cost of the user agency".

Hence, , the Authorized Signatory, Reliance Jio Inficomm Limited, 22nd floor, KBR Heights, 40-1-116 & 117, M.G Road, Vijayawada – 520010, Andhra Pradesh is requested to pay all the levies as per aforesaid instructions and comply with all the conditions stipulated by the Government of Andhra Pradesh and submit condition wise compliance report of Forest and Wildlife Clearances to this office immediately for taking further course of action

Further, the User Agency is also requested to comply with the following in accordance with the Government of India instructions issued vide F.No.7-23/2012-FC, Dated:24.07.2013 communicated vide Principal Chief Conservator of Forests & HoFF, AP, Mangalagiri Rc.No. 45921 / 2001 – F4, Dated:23.08.2013 and also instructions issued to publish the orders at the cost of the project proponent.

- Publish the entire forest clearance granted in variation along with the condition and safe guards impose by the Central Government in two widely circulated daily news papers one in vernacular language and another in English language so as to make people aware of the permission granted to the project proponents for use of forest land for non forestry purpose.
- The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayaths, and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30days.
