1. The **Stage-I approval** was accorded by State Government to the proposal file no **File No.FOREST-FCA0FC3D/8/2022-FCA letter I/521066/2023 dated 02.03.2023** Divisional Forest Officer **Dasuya** has submitted compliance report vide letter no. **I/555182/2023** dated **05.05.2023** .Government of India has accorded general approval under the Forest Conservation Act, 1980 vide leter No. 11-9/98-FC dated 08.04.2009 dated 02.02.2015 in the case of laying of Underground Telephone Lines, Optical fiber Cable/Underground Laying of Drinking Water Supply Pipeline.

The Nodal Officer (FCA) has been authorized by the State Government to issue Final Approval vide e-office file no. 38957. After careful examination of the proposal under General Approvals issued by Govt. of India vide letter No. F.No. 5-2/2017-FC dated 28.03.2019, "Stage-II approval" is hereby conveyed for diversion of 0.445 ha. of forest land for digging of trenches measuring 11118 mtrs. Long and 0.4 mtrs wide and 2.0 mtrs depth along the road for laying for laying 125 mm dia PE Natural Gas Pipeline parallel & across to Road/River side strip plantation declared as protected forest in Miani Village Connectivity of forest land for the above mentioned proposal subject to the following conditions:-

- 1. Legal status of the forest land will remain unchanged.
- 2. The forest land will not be used for any other purpose.
- 3. No tree will be felled by the user agency.
- 4. User Agency has deposited the 50% NPV as per the Handbook of Forest (Conservation) Act, 1980 and Forest Conservation Rules, 2003 (Guidelines & Clarification).
- 5. User Agency has given Bank Guarantee of Rs. 2,77,950/- to **DFO, Dasuya.**
- 6. It is Mandatory for the User Agency not to exceed the permissible

- trench limit of 0.4 meter in width, 2.0 meter in depth and 11118 meter in Length.
- 7. The Optical Fiber Cable will be laid along the road within the existing right of way and close to the outermost edge of the forest land. The dug out land shall be restored by the User Agency and the same shall be made good immediately after the approved operation.
- 8. User agency shall obtain the Environment Clearance under prevailing Acts/Rules/Guidelines, if applicable.
- 9. This approval is subject to the clearance of the proposal under relevant local Acts/Rules/Court's Rulings/instructions etc. as applicable.
- 10. The User Agency shall seek prior permission from the **DFO**, **Dasuya** for carrying out any maintenance operation.
- 11. The User Agency shall abide by any other condition (s) that may be imposed by this Department in the interest of afforestation and protection of environment.
- 12. The State Forest Department may revoke/suspend this approval, if any of the above conditions is not satisfactorily fulfilled by the User Agency.
- 13.An undertaking is signed by the User Agency for abiding by all the aforesaid conditions.
- 14.If any other NOC is necessary under any Act/Rules/Guidelines etc. from other Departments, the user agency should obtain the same before the commencement of laying of Cable.
- 15.CF, North Circle, Hoshiarpur/DFO, Dasuya shall ensure fulfillment of the above conditions.`
