Sir,

Please refer to the case of diversion of 0.5975 Ha forest land for up-gradation of road from Kotli to Shikari in Mahore Forest Division as per online proposal referred above.

- I am directed to convey in-principle approval for for up-gradation of road 2. from Kotli to Shikari in Mahore Forest Division subject to the fulfilment of following terms and conditions:-
 - Conditions which need to be complied prior to handing over of forest (A) land by the J&K Forest Department.
 - Cost of compensatory afforestation as per scheme may be realized from the user agency; i)
 - Net Present Value (NPV) of the forest land being diverted for non-forestry purpose may ii) be realized from the user agency, as per MoEF&CC directions issued vide letters No. 5-3/2007-FC dated 5th February 2009 and Hon'ble Supreme Court of India's Order dated 30th October 2002, 28th March, 2008, 24th April, 2008 and 9th May 2008;
 - The Net Present Value (NPV) of the forest land and all other CA levies shall be deposited through web portal of Ministry of Environment, Forest and Climate Change iii) www.parivesh.nic.in;
 - User agency should ensure that the compensatory levies (CA cost, NPV, etc.) are deposited through challan generated online on web portal and deposited in appropriate iv) bank only. Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance;

Original copy of FRA certificate to be submitted; v)

Divisional Forest Office shall furnish undertaking that the approved CA sites will not be changed without the approval of the Competent Authority.

The CEO State CAMPA shall furnish undertaking that the funds under State CAMPA will be released to Divisional Forest Officer as per approved CA scheme.

Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per law.

- Conditions which need to be strictly complied on field after handing over of **(B)** forest land to the user agency by the J&K Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II
- Legal status of the forest land shall remain unchanged; i)
- Efforts should be made to fell minimum number of trees; ii)
- iii) The CA will be carried out over 1.20 ha on degraded forest land as per the CA scheme and the funds will be provided by the user agency. The plantation will be done within one year from the date of issue of the approval;
- The layout plan of the proposal shall not be changed without prior approval of Central iv) Government:
- No labour camp shall be established on the forest land; v)
- vi) Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel;
- No additional or new path will be constructed inside the forest area for transportation of vii) construction materials for execution of the project work;
- The period of diversion under this approval shall be co-terminus with the period of lease viii) to be granted in favour of the user agency or the project life, whichever is less;
- The forest land shall not be used for any purpose other than that specified in the project ix) proposal;
- The forest land proposed to be diverted shall under no circumstances be transferred to x) any other agencies, department or person without prior approval of Govt. of India; and
- Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development xi) of forests & wildlife
- User Agency shall obtain Environment Clearance or any other clearance, if applicable under any act/rule/order/guideline etc for the proposal.
- After receipt of the compliance report on fulfillment of the conditions under para-2, above, final approval order shall be given under Section-2 of the Forest (Conservation) Act, 1980. The use of forest land will not be allowed till final approval is accorded.
