## - Demand Notice -

Sub

Diversion of 1.74 (Revised from 1.84) ha of forest land in Sy No, 25 of Chikkakasanakandi Village and submerged village of Hole Mudlapur and Lingapur villages, Hitnal Hobli, Koppal taluk & Disrtict for laying of pipeline, Transmission Line, Substation and break pressure Tank in favour of M/s Baldota Steel and Power Limited Hosapete, Ballari District (*Proposal No. FP/KA/IND/26447/2017 [Stage-1 approved]*.

With reference to the above subject, the Government of India, Ministry of Environment, Forest & Climate Change (Forest Conservation Division), Bengaluru has accorded 'In-principle (Stage-I) approval.

In this regard, vide Ref(2) the Principal Chief Conservator of Forests (Forest Conservation) & Nodal officer, Bangalore has directed the User Agency

1. To make all statutory payments (NPV, CA, etc.) mentioned in the conditions of Stage-I approval through the Government of India web portal 'www.parivesh.nic.in'. In this regard you are requested to upload the Demand Notice obtained from the Deputy Conservator of Forests, Koppal Division for acceptance by this office and then to generate the Challan from the said web portal for making payment.

2. To upload the condition-wise Compliance Report in respect of all the conditions stipulated in Stage-I approval on the said web portal and submit the hard copy of the same along with relevant supporting.documents to the Deputy Conservator of forests, Koppal Division for field verification and further processing.

Further, it is observed that, the Government of India, Ministry of Environment, Forest & Climate Change (Forest Conservation Division), Bengaluru has imposed

following conditions regarding Raising of Compensatory Afforestation in non-forest land vide Ref(3).

The conditions are reproduced herewith;

- 3. The equal extent non-forest land identified for the purpose of raising Compensatory in Sy. No.131/BP1, Chatnihalli village, Harapanahalli Taluk, Davanagera District shall be notified has RF / PF before handing over the forest land to user agency by the state Government. The nodal officer, after notification of such forest lands, shall uploaded a copy of the said notification on PARIVESH portal.
- 4. The User Agency shall transfer the cost of raising and maintaining the compensatory afforestation at the current wage rate in consultation with state forest department in the designated CAMPA account of the concerned state through online portal as per approved CA scheme.
- 5. Compensatory Afforestation (CA) shall be carried in equal extent of non forest land identified in Sy No, 131/BPl, Chatnihalli village, of Davanagera District within the timeline provided under van (Sanrakshan Evam Samvardhan) rules 2023.
- 6. And also the user agency shall transfer online, the net present value (NPV) of the forest land being diverted under this proposal as per the guidelines issued by ministry vide letter No, 5-3/2011-FC(Vol-I) dated:06/01/2022 and as per the provision of chapter-3 of the consolidated guidline and clarification issued vide MoEF and CC order dated:29/12/2023

Further, it is directed to submit the compliance report (ink-signed hard copies) in 8 sets along with documents through Range Forest Officer, Koppal Range, Munirabad and Assistant Conservator of Forests, Koppal Sub Division Koppal for field verification and further processing.
