It is informed that, in the reference 3rd cited, the GoI, MoEF & CC, IRO, Vijayawada have issued Stage-I approval for diversion of 1.23 ha. of forest land in Compt.no.1333 & 1291 of Pedavalasa RL for formation of road from Nerellabanda to Sagulu via Yerracheruvulu of G.K.Veeedhi Mandal in R.V.Nagar Range in favour of the Executive Engineer, Panchayat Raj (PIU) Division, Paderu with certain conditions.

Hence, the Executive Engineer, Panchayat Raj (PIU) Division, Paderu is requested to go through the conditions stipulated from (i) to (xxiv) in the GoI, MoEF & CC, IRO, Vijayawada Lr.F.no.4-APB162/2022-VIJ/313, dt.30.04.2022 and also follow the instructions issued by the Prl.Chief Conservator of Forests (HoFF) A.P. Guntur in the reference 5th cited and the Chief Conservator of Forests, Visakhapatnam in the reference 6th cited without any deviation and publish the orders at the cost of the project proponent.

 Publish the entire forest clearances granted in verbatim along with the conditions and safe guards imposed by the Central Government in two widely

- circulated daily newspapers, one in vernacular language and another in English language so as to make people aware of permission granted to the project proponent for use of forest land for non-forestry purposes.
- The copies of the Forest Clearance should also be submitted to the Heads of local Bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

In the reference 2nd cited, the Prl.Chief Conservator of Forests (HoFF) A.P. Guntur has communicated proforma for payment of NPV, CA etc., amounts through e-payment mode i.e., challan generated through the Ministry's web portal (i.e., www.parivesh.nic.in) only for diversion of forest land for non-forestry purpose Stage-I/II approval accorded Payment of Compensatory levies by User agencies certain anomalies noticed in Demand notices issued by DFOs. I. (a) Procedure for e- challan generation:

- On issue of this demand notice, the user agency shall log in to Forest Clearance portal www.parivesh.nic.in to generate e-challan and make payment against the demand.
- ii. Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

I. (b) Procedure for Payment through NEFT/RTGS:

- iv. For payment through RTGS, the representative of the agency should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed echallan with an Account Number printed on it.
- v. While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- vi. Upon executing the RTGS by the sender/ remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.



Sir,

Please refer to the State Government's letter Nos. 771/Section. II/2022/(1389691) dated 13.04.2022 (received on 19.04.2022) and online proposal No. FP/AP/ROAD/49021/2020 on 20.04.2022 seeking prior approval of the Central Government for diversion of forest land in accordance with Section'2' of Forest (Conservation) Act, 1980 for the above mentioned project.

After careful consideration of the proposal of the State Government, I am to convey the Central Government's in principle approval (Stage-I) under Section '2' of Forest (Conservation) Act, 1980 for diversion of 1.23 ha. of forest land in Compartment Nos.1291 & 1333 of pedavalasa RL in Pedavalasa North Beat of R.V.Nagar Range of Narsipatnam division for formation and BT to the road including construction of culverts from Nerellabanda to Sagulu of G.K.Veedhi Mandal in favour of Executive Engineer, PR, Paderu, subject to the following conditions:-

- Legal status of the diverted forest land shall remain unchanged;
- (ii) Demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at the cost of the User Agency;

Vanae

- (iii) The State Forest Department shall carryout plantation and its maintenance over an extent of 1.23 ha (within 25.52 ha) of non forest area in Sy. no. 418-P of Kommika (V), Koyyuru Mandal, Visakhapatnam District, at the cost of the User Agency;
- (iv) As per the google images, it appears that the non forest area identified for CA purpose is having good vegetation, hence, in case, if not possible to plant required numbers i.e. 1000 plants/ha, the State Forest Department may carryout balance plantation in the nearby suitable degraded forest area. Details of such degraded forest area i.e map, kml file etc shall be submitted along with the compliance report and same may also be uploaded in the web portal;
- (v) The Non forest area identified for CA purpose and CA scheme shall not be changed without prior approval of the Central Government. The CA land shall be demarcated properly and local villagers are adequately sensitized regarding the transfer of this parcel of land to Forest Department so as to avoid encroachments;
- (vi) Entire non-forest land identified over an extent of 25.52 ha of non forest area in Sy. no. 418-P of Kommika (V), Koyyuru Mandal, Visakhapatnam District for raising compensatory afforestation shall be transferred and mutated in favour of the State Forest Department and shall notified as RF/ PF before issue of the Stage-II clearance. Copy of such notification shall be submitted along with the compliance report;
- (vii) The State Government shall charge the Net Present Value of the diverted forest land measuring 1.23 ha from the User Agency as per the orders of the Hon'ble Supreme Court dated 28.03.2008 and 09.05.2008 in IA Nos.826 in 566 with related IA's in Writ Petition (Civil) No.202/1995 and Ministry's guideline No. 5-3/2011-FC(Vol-I) dated 06.01.2022 and clarification issued vide letter dated 19.01.2022;
- (viii) Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect;
- (ix) All the funds received from the User Agency under the project shall be transferred/ deposited to CAMPA fund only through e-portal (https://parivesh.nic.in/);

Udual

- Felling of trees shall be carried out in the diverted forest area under strict supervision of DFO concerned;
- (xi) The User Agency shall construct retaining walls and check walls wherever required, by consulting the DFO concerned, at the project cost;
- (xii) Construction of culverts/bridges, if any, over the natural streams/rivers/canals shall be done in such a manner that it does not hamper the natural course of water, does not give rise to water-logging, and also does not hamper movement of wild animals;
- (xiii) Roadside cuttings and fillings which require engineering support shall be provided as per the instructions of the DFO concerned so as to stabilize the soil;
- (xiv) The dug out material / overburden shall be dumped outside the forest area. Storage of any material shall not be done in the forest area;
- (xv) The layout plan of the proposal shall not be changed without the prior approval of the Central Government;
- (xvi) The User Agency shall provide fire wood preferably alternate fuel to labourers working at the site to avoid damage/tree felling and no labour camp shall be established inside the forest area;
- (xvii) Disturbance shall be kept minimum by creating labour camps outside the forest area as far as possible and it shall be the responsibility of the User Agency to ensure that the labourers & staff engaged in execution of work do not destruct nearby forest flora & fauna;
- (xviii) The total forest area utilized for the project shall not exceed 1.23 ha (including existing cart road/ pathway) and BT portion shall be restricted to 3.75 mtrs and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal. The User Agency shall furnish an undertaking to this effect;
- (xix) The forest land proposed for diversion shall under no circumstances be transferred or sublet to any other agency, department or person without prior approval of the Central Government;
- (xx) No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.

Vanae

- (xxi) The User Agency and the State Government shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project;
- (xxii) Any other conditions that the Central Government or Regional Officer (Central) of Integrated Regional Office, Vijayawada may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the User Agency;
- (xxiii) In the event of failure to comply with any of the above conditions the User Agency is liable for penal action as per the provisions under rules / guidelines issued under FCA, 1980.
- (xxiv) The State Government shall process and submit compliance report on the above conditions through online(https://parivesh.nic.in/);

After receipt of the compliance report on above mentioned conditions, the proposal will be considered for final approval. This in-principle approval shall be valid for a period of 5 years from the date of issue of this letter. In the event of non-compliance of the above conditions, this in-principle approval shall automatically stand revoked after 5 years.
