It is submitted that, in the reference 1st cited, the Government of Andhra Pradesh, Environment, Forests, Science & Technology has communicated In-principle / Stage-I approval under Forest (Conservation) Act,1980 pertaining to Diversion of 2.65 ha of forest land in Compartment no.860 of Sankaram RL and Compartment no.861, 862 & 808 of Madugula Beat, Visakhapatnam Division for formation of road from Paderu Waddadi R&B road to Konam via Poolabanda (PV R&B road 12 mile to Devapuram) in favour of Executive Engineer, Panchayat Raj (PIU) Division, Paderu. The same was communicated by the Prl.Chief Conservator of Forests (HoFF) A.P. Guntur in the reference 2nd cited

In this connection, the Executive Engineer, Panchayat Raj (PIU) Division, Paderu is requested to go through the conditions stipulated in **Conditions from i to xxiv but the compliance in form of undertaking shall be submitted prior to Stage-II approval and also follow the instructions issued by the Prl.Chief Conservator of Forests (HoFF) A.P. Guntur without any deviation.**

In the reference 2nd cited, the Prl.Chief Conservator of Forests (HoFF) A.P. Guntur has instructed to issue demand notice to the user agency in the proforma communicated in Rc.no.45921/2001/FCA-4, dt:22.12.2017 for payment of NPV, CA etc., amounts to Adhoc-CAMPA through **e-payment mode i.e. challan generated through the Ministry's web portal (i.e. www.parivesh.nic.in) only**, as per the guidelines issued by the Ad-hoc CAMPA, New Delhi letter, dt:09.06.2016. The payment shall be made only in Corporation Bank.

I. Amount demanded to be deposited in Adhoc CAMPA, Corporation Bank, Lodhi Road, New Delhi through e-challan only.



CORP0000371) and submit the receipts along with the compliance report to the conditions stipulated in the references cited point wise for onward submission to the Chief Conservator of Forests / Conservator of Forests, Visakhapatnam for further action in the matter
