Diversion of 1.75 ha. of forest land in Sy.No. 1 of Rampura Karuvinahatti village, Karuvinahatti Kaval Reserved Forest of Kanakapura Range, Ramanagara Division for establishing 765 KV S/C Transmission Line from Dharmapuri (Salem) -Madhugiri (Tumkur) covering the States of Tamil Nadu and Karnataka in favour of the Chief Manager, Power Grid NM Transmission Ltd, Singanayakanahalli, Bangalore.

Sir.

Please refer to the State Government's letter No.FEE 45 FGL 2018 dated 30/04/2018, 4/08/2018 and 13/08/2018 seeking prior approval of the Central Government in accordance with Section'2' of Forest (Conservation) Act, 1980 in respect of the above project.

After careful consideration of the proposal, I am directed to convey Central Government's approval in-principle **(Stage-I)** under Section'2' of Forest (Conservation) Act, 1980 for diversion of 1.75 ha. of forest land in Sy.No. 1 of Rampura Karuvinahatti village, Karuvinahatti Kaval Reserved Forest of Kanakapura Range, Ramanagara Division for establishing 765 KV S/C Transmission Line from Dharmapuri (Salem) -Madhugiri (Tumkur) covering the States of Tamil Nadu and Karnataka in favour of the Chief Manager, Power Grid NM Transmission Ltd, Singanayakanahalli, Bangalore, for a period of 20 years, subject to the following conditions:-

- The legal status of forest land shall remain unchangeo.
- 2. The demarcation of the proposed forest area shall be carried out by erecting cement concrete pillars duly numbered at an interval of 20 meters at the cost of User Agency, before Stage-II approval.
- The cost of raising Compensatory Afforestation over double the degraded forest land over an extent of 3.5ha. in Sy.No. 76 of Bairashattihalli village, Narikallugudda Reserve Forests, Channapattana Range, Ramanagara District shall be realized from the User Agency.
- 4. The State Government shall charge the Net Present Value of the diverted forest land measuring 1.75 ha. from User Agency as per the orders of the Hon'ble Supreme Court dated 28.03.2008 and 09.05.2008 in IA Nos.826 in 566 with related IA's in Writ Petition (Civil) No.202/1995.

- 5. Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from User Agency. User Agency shall furnish an undertaking to this effect.
- 6. User Agency should ensure that the compensatory levies are deposited in the appropriate bank through challan generated online on the web portal. Amount deposited through other modes will not be accepted as compliance of the Stage –I clearance.
- 7. Necessary certificates/documents under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006 as per the guidelines issued by Ministry of Environment & Forests vide letter No.11-9/1998-FC (Pt) dated 05.07.2013 shall be furnished before Stage-II clearance.
- 8. Plantation of dwarf species (preferably medicinal plants) in the right of way under the transmission line shall be taken up at the cost of User Agency.
- 9. Guidelines issued by the Ministry vide letter No. 7-25/2012 –FC dated 5/5/2014 for laying of transmission lines through forest areas shall be strictly followed.
- 10. The forest area shall be used for the purpose for which it is granted. The total forest area utilized for the project shall not exceed 1.75 ha.
- 11. A separate proposal for diversion of forest land under Forest (Conservation) Act, 1980, falling in Bannerghatta National Park associated with the instant transmission line shall be submitted after necessary clearance from the Standing Committee of NBWL.
- 12. Any other condition that the Additional Principal Chief Conservator of Forests (Central), Regional Office, Bangalore may impose from time to time for protection, improvement of flora and fauna in the forest area and public convenience, shall also be applicable.
- Violation of any of the conditions shall invite penal action, as deemed fit by the Additional Principal Chief Conservator of Forests (Central), Regional Office, Bangalore.

After receipt of the compliance report on the above conditions, the proposal will be considered for final approval. This in-principle approval shall be valid for a period of 5 years and the forest land shall not be transferred to the User Agency prior to the issue of final approval.
