It is to inform that, the Stage-I approval is accorded by the GOI for Diversion of 3.26 ha of Forest land (2.67 ha of forest land in Matlatippa RF and 0.59 ha Mangrove Forest land) for laying of 20" pipeline (about 31km) from offshore platform through mouth of the Gowthami river to ONGC onshore plant at East Godavari District in favour of M/s ONGC, Kakinada. The Principal Chief Conservator of Forests, Andhra Pradesh, Guntur issued instructions vide reference 2nd cited, for collection of the Net Present Value amount.

1. (a) Procedure for e-challan generation:

- 1. On issue of this demand notice, the user agency shall log in to Forest Clearance portal forestclearance.nic.in to generate e-challan and make payment against the demand.
- 2. Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- 3. Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

1. (b) Procedure for Payment through RTGS:

- 4. For payment through RTGS the representative of the agency should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed e-challan with an Account Number printed on it.
