With reference to the above cited memo on the captioned subject, it is to inform you that, as per the Condition No. IV of Stage-I approval order, the revised scheme for plantation of Compensatory Afforestation at the current wage rate of Rs.326/- per manday, which has been technically approved by the Chief Conservator of Forest (FD & NO, FC Act), O/o the P.C.C.F. & HoFF, Odisha, Bhubaneswar with a financial outlay of Rs.19,30,000/- (Rupees Nineteen Lakh Thirty Thousand) only including maintenance of 10 years. You have already deposited an amount of Rs.8,90,500/- only towards Plantation of Compensatory Afforestation as per the previous approval.

Hence, you are requested to deposit the differential amount of Rs-10,39,500/- (Rupees Ten Lakh Thirty Nine Thousand Five Hundred) only towards the cost of revised Compensatory Afforestation in respect of Athmallik Forest Division as per the current approval.
