Cost of NPV for non-forest land @14,36,670.00 per/ha. over 3.086 ha. = Rs. 44,33,564/-

Compensatory Afforestation over 5.0 ha. = Rs. 23,50,325/ii)

Total = Rs.1,14,84,538/-Overhead cost iii)
