
Through above-mentioned letter, a request has been made that, as per MoEF&CC, GoI guideline dated 7th June 2022, in cases where it is not possible for the State to submit the compliance due to delay in preparation of such plan, a lump sum quantum of project cost may be realized from the User Agency and submitted along with the Stage I compliance. Accordingly, it has been requested to raise a demand of indicative amount equal to 0.5% of the project cost for implementation of Soil & Moisture Conservation Plan as mandated under In-principle approval of the project.

Through above-mentioned letter, Minutes of 399<sup>th</sup> CIL Board meeting held on 11<sup>th</sup> Feb 2020 has been attached, wherein, at para 4.5 the total capital investment of Expansion Project of Amraplai OCP 25 MTY has been recasted to be 5136.15 Crores.

Therefore, it is requested to deposit the indicative lump sum amount of Rs. 25.68 Crores (0.5% of the project cost) in CAMPA Account for Soil & Moisture Conservation Plan. The amount should be deposited to CAMPA fund only through e-portal (<https://parivesh.nic.in>) against 431.59 ha of forest land in favor of Chatra South Forest Division alongwith an undertaking for depositing additional amount, if so determined, as per final approval of the Soil and Moisture Conservation Plan.

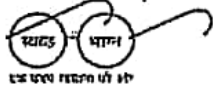

Sub: Minutes of 399<sup>th</sup> CIL Board Meeting held on 11<sup>th</sup> Feb.'2020.

Reproduced below is the relevant extracts from the minutes of 399<sup>th</sup> meeting of Board of Directors of Coal India Limited held on 11<sup>th</sup> Feb.'2020 at New Delhi with regard to the following item:

**"ITEM NO.399.4E**

**Sub: Recast Expansion PR of Amrapali OCP (25MTY), CCL.**

- 4.5 Director (Technical) apprised the Board that this Project Report was discussed in 101<sup>st</sup> Empowered Sub-Committee meeting of CIL held on 21<sup>st</sup> January'2020. The Committee had recommended implementation of the Project under Variant-III (i.e. East Section Departmental and West Section outsourcing)) and dovetailing Amrapali OCP Project (12 MTY).

Thereafter, Director (Technical) P&P, CCL made presentation on the Project. Board advised to ensure that :

- a) equipment configuration for contractual work should be at least the same as departmental configuration
- b) outsourcing contract should be for the life of the equipment. and
- c) expenditure incurred on Tori-Shivpur railway line to extent it is not reimbursed should be included proportionately in all the projects that uses the railway line.


Company Secretary apprised the Board that as per DPE guidelines, Maharatna Company has full power to approve Project Report if its Board is fully constituted as per SEBI LODR'2015 or at least 4 Independent Directors are in the Board. In the absence of five Independent Directors in CIL Board, to expedite project implementation, as decided in 396<sup>th</sup> Board meeting held on 19<sup>th</sup> Dec.'2019, it is proposed to grant in-principle approval to the Project Report and also grant approval for the first year capital expenditure as per the recommendation of ESC for Evaluation, Appraisal and Approval of Projects. As soon as the Board is fully constituted as required under Listing Regulations 2015 or at least 4 Independent Directors are in the Board, this project report would be re-submitted for obtaining the approval of total capital investment of the project.

In view of the above and as recommended by Empowered Sub-Committee, Board accorded its in-principle approval to Recast Expansion Project Report of Amrapali OCP for a rated capacity of 25 MTY (Peak 35 MTY) with total capital investment of Rs.5136.15 Crores (including Rs.748.36 Crores washery capital) for entire life of the project for implementation of the project under Variant-III (East Section Departmental and West Section Outsourcing) and dovetailing Amrapali OCP Project (12 MTY) as brought out in the agenda note.

Further, Board also approved 1<sup>st</sup> year capital expenditure of Rs.571.89 Crores for implementation of the project. Further Board advised that as soon as the Board is fully reconstituted or at least 4 Independent Directors are in the Board to place this Project Report for its consideration."
