विषयांकित प्रकरण में भारत सरकार, पर्यावरण वन एवं जलवायु परिवर्तन मंत्रालय, क्षेत्रीय कार्यालय, पश्चिम क्षेत्र, भोपाल ने अपने पत्र क्रमांक 6-MPC 057/2021-BHO, दिनांक 09.11.2021 से अधिरोपित शर्तों के तहत सैद्धान्तिक सहमति प्रदान की गई है, जिसकी छायाप्रति संलग्न है। प्रकरण में कैम्पा मद में जमा होने वाली सभी राशियों का भुगतान भारत सरकार, पर्यावरण वन एवं जलवायु परिवर्तन मंत्रालय की ई-पोर्टल के माध्यम से ही किया जाना है।

शर्त संख्या-A(1) के अनुपालन में वैकल्पिक वृक्षारोपण योजना की राशि रु. 67,63,113/- कैम्पा मद में जमा करावे। वैकल्पिक वृक्षारोपण के पर्यवेक्षण शुल्क की राशि रु.7,43,942/- एम.पी. ऑनलाईन ट्रेजरी अथवा डी.डी. के माध्यम से वनमण्डल, खण्डवा में जमा कराई जावे।

शर्त संख्या-A(2) के अनुपालन में नेट प्रजेंट वैल्यू की राशि रु. 35,68,200/- कैम्पा मद में जमा करावे।

शर्त संख्या-A(3) के अनुपालन में स्थल विशिष्ट वन्यप्राणी प्रबंधन योजना तैयार कराकर प्रस्तुत करे।

शर्त संख्या-A(5) के अनुपालन में वन अधिकार अधिनियम, 2006 के तहत कलेक्टर जिला खण्डवा का प्रमाण पत्र प्रस्तुत करे।

शर्त संख्या-B(3) के अनुपालन में अतिरिक्त एन.पी.व्ही. की राशि का वचन पत्र प्रस्तुत करे।

भारत सरकार की सैद्धान्तिक अनुमति की सभी शर्तों का अनुपालन प्रतिवेदन प्रस्तुत करे तथा पोर्टल पर अपलोड कर इस कार्यालय को 02 प्रति में प्रस्तुत करे ताकि प्रकरण में औपचारिक स्वीकृति प्राप्त करने की कार्यवाही की जा सके।



Sub: In-principle (Stage-I) approval of Central Government under Forest (Conservation) Act 1980 for diversion of 5.700 Reserved Forest land for construction of Kodwar 33 KV Transmission line to Pump House 1 and Pump House-2 in Village-Kodwar in favour of Executive Engineer, Narmada Development Division No. 25 in Khandwa District of Madhya Pradesh – reg.

Sir,

This refers to letter No. F-4/112/2021/10-11/3454 dated 13/10/2021 of PCCF(LM), Govt. of Madhya Pradesh on the above mentioned subject seeking prior approval of the Ministry of Environment, Forest and Climate Change under section 2 of Forest (Conservation) Act, 1980.

After due consideration of the proposal of the State Government and on the decision of Regional Empowered Committee in its 14th meeting of 2021 on 02/11/2021, the "In-principle" approval of Central Government, is hereby conveyed for diversion of 5.700 Reserved Forest land for construction of Kodwar 33 KV Transmission line to Pump House 1 and Pump House-2 in Village-Kodwar in favour of Executive Engineer, Narmada Development Division No. 25 in Khandwa District of Madhya Pradesh subject to the following conditions and stipulations.

A: Conditions which need to be complied prior with handing over of forest land by the State Forest Department.

- (1) The cost of compensatory afforestation on the CA land (12.00 ha) at the prevailing wage rates as per compensatory afforestation scheme (including the cost of survey, demarcation and erection of permanent pillars etc. as required for securing the land against encroachment) shall be deposited in advance with the State Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years. ✓
- (2) The State Government shall charge the Net Present Value (NPV) for the 5.70 ha forest area to be diverted under this proposal from the User Agency as per the order of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 and chapter 3 of FCA Handbook, 2019 in this regard. ✓
- (3) The User Agency should prepare a site specific *Wildlife Management Plan* to mitigate the effects of the project over wildlife before the issuance of Stage-II approval and implemented by User Agency at their own project cost. ✓
- (4) All the funds received from the user agency under the project shall be transferred / deposited to CAMPA fund only through e-portal (<https://parivesh.nic.in/>). ✓
- (5) The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector. ✓

- (6) Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of Comprehensive Guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated 28.03.2019.
- (7) The compliance report shall be uploaded on e-portal (<https://parivesh.nic.in/>).
- (8) The KML files of the area to be diverted, the CA areas, the proposed SMC work, the proposed Catchment Area Treatment area and the WLMP area shall be uploaded on the e-Green watch portal with all requisite details before issuing working permission towards linear projects or submitting compliance report for seeking Stage-II approval, as the case may be.

B: Conditions which need to be strictly complied on field after handing over of forest land to the User Agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval:

- (1) Legal status of the forest land shall remain unchanged.
- (2) Compensatory afforestation shall be taken up by the Forest Department over 12.00 ha degraded forest land at Survey No. 73, Forest Range-Mundi, Tehsil-Punasha, District-Khandwa at the cost of the user agency. As far as possible, a mixture of local native species shall be planted and monoculture of any species, especially non-native species should be avoided.
- (3) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall also be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect. ✓
- (4) User Agency shall restrict the felling of trees to 978 numbers / minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- (5) The User Agency should fence the base of the tower by Chain Link Fencing to prevent the electrocution of Elephant/ Wild Animals in forest area at their own cost. The concerned DCF shall inspect the area and shall take a decision as to the specific towers which shall be fenced.
- (6) *The State Forest Department shall plant 12000 saplings in proposed CA area and submit a detailed report to this office.*
- (7) *The User Agency shall comply with the guideline for laying transmission lines through forest as per Chapter 10 of FCA, 1980 Handbook, 2019.*
- (8) The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Dy. Conservator of Forest.
- (9) The layout plan of the proposal shall not be changed without prior approval of Central Government.
- (10) No labour camp shall be established on the forest land.
- (11) The User Agency shall provide alternate fuels preferably LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
- (12) No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- (13) The period of diversion under this approval shall be co-terminus with the period of the project life.
- (14) The forest land shall not be used for any purpose other than that specified in the project proposal.
- (15) The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department, or person without prior approval of Central Government.



- (16) Any other condition that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forest & wildlife.

2. After receipt of the compliance report regarding fulfillment of the conditions as stipulated above, from the State Government, formal approval will be issued in this regard under Section 2 of Forest (Conservation) Act, 1980. Transfer of forest land to user agency should not be given effect to by the State Government till formal order approving diversion of forest land is issued by the Central Government. To facilitate speedy execution of this project involving diversion for the transmission line, the in-principle approval may be deemed as the permission for commencement of works, if the required funds for CA, NPV and other compensatory levies specified in the in-principle approval are realized from the user agency and accordingly the State Government, by passing an order, may allow the commencement of work of the linear project in forest land for a period of one year (The detail guideline issued vide Ministry letter No. 11-306/2014-FC, dated 28.08.2015 may be referred).

This has been issued with the approval of the Competent Authority.


