
Sir,

This is in continuation to the above referred letter, I am hereby directed to inform you that the payment towards Net Present Value has not been received from your side, which is mandatory as per Hon'ble Supreme Court's order dated 28.03.2008 in Writ Petition (Civil) No. 202 of 1996 in the matter of T.N. Godavarman Thirumalpad vs. Union of India and Ministry's guidelines dated 05.02.2009.

In this regards, you are directed to pay **₹ 1,99,952/-** (Rupees: **One Lakh Ninety Nine Thousand Nine Hundred Fifty Two only**) towards Net Present Value of the forest land diverted for laying of 8" dia steel pipeline in Chinchpada village of U.T. of Dadra & Nagar Haveli **through challan** generated **through online mode** in favour of Compensatory Afforestation Fund (CAF) Dadra & Nagar Haveli and copy of the proof / evidence may be submitted to this office for completion of diversion proposal and granting of Stage - II approval.
