As per Stage-I (in-Principle) approval accorded for Diversion of 0.15 Ha of Forest land for widening of road from Phinter to Billawar road along with balance work of Billawar to Sukralla, District Kathua, by the Government of India, Ministry of Environment, Forest and Climate change (Forest Conservation Division), vide File No: 9-JKC-096/2021-Jammu dated: 07-01-2022, under section-2 of Forest (Conservation) Act, 1980, the following Compensatory levies are chargeable from the User Agency which need to be deposited by the User Agency as per the detail given below:
