With reference to the subject cited above, please find the enclosed herewith the estimate cost of Net Present Value, Compensatory Afforestation and Over Head Cost (as per latest notification of minimum wage rate) against the forest diversion proposal for 0.81 Ha of forest land for upgradation of National Highway from Dillai to Lahorijan from KM 145+712 to Km 156+502 (Pkg-7) of NH-29 in the state of Assam under Bharatmala Pariyojana on EPC mode.

The details breakup of the cost is as follows:-

1. Cost of NPV over 0.81 Ha	=	Rs. 15,51,107.88
2. Compensatory Afforestation over 1.62 Ha	=	Rs. 29,86,012.21
3. Overhead Cost	=	Rs. 14,93,006.10
4. Operation of tree felling, dragging, stacking etc	=	Rs. 11,15,026.22
Total		= Rs. 71,45,152.41
