The Government of India vide Ref(1) has accorded 'in-principlie'(Stage-I) approval under Section-2 of Forerst (Conservation) Act, 1980 for diversion of 0.98ha of forest land in

Sy.No.79/P1 Sonnenehalli Village, Hesaraghatta Hobli, Bengaluru North (Additonal) Taluk, Bengaluru Urban District for construction of 400 kV D/C Quad Tumkur (Vasanthanarasapura) to Yelahanka Transmission line in Bengaluru Urban District (and Forest Division) subject to certain conditions. The same was sent to your office for submission of compliance of the conditions of Stage-I approval.

In response, vide ref(9) the compliance report submitted was duly verified and the following information is further sought,

(1) With regard to condition No.A(2), the User Agency has to remit the Cost of raising plantation of ten times the number of trees to be felled – 114 trees (114 trees x 10 times = 1140 Trees) i.e. Rs.23,12,000/- as intimated by this office letter vide Ref(8). The same was remitted and the copy of the remittance challan was submitted to this office vide letter Ref(9).

However, the Compensatory Afforestation charges have been revised vide O.M. No. Letter No.KFD/HoFF/A5-4(GFL)/34/2019-FC dated: 22.08.2023 of the Principal Chief Conservator of Forests (Forest Conservation) and Nodal Officer (FCA).

The cost of raising plantation of ten times the number of trees to be felled – 114 trees (114 trees x 10 times = 1140 Trees) as calculated as per the rates revised in the above OM are

Difference amount to be remitted	Rs. 75,960/-
Amount already remitted	Rs.23,12,000/-
Actual amount to be remitted	Rs.23,87,960/-

With regard to condition No.A(11), the photographs of all the 26 boundary pillars each inscribed with its serial number, GPS co-ordinates has to be submitted.
