With reference to above, this is to inform you that the Site Specific Wildlife Conservation Plan for Netrabandha Pahar Iron Ore Block of M/s Bhushan Power & Steel Ltd. in Sundargarh District, Odisha has been approved by the PCCF (WL) & CWLW, Odisha with financial forecast of ₹ 549.33 Lakhs (Bonai Division-378.68 Lakh + Keonjhar Division-170.65 Lakhs) for the activities to be implemented by Bonai Division and Keonjhar Division. So, you are requested to deposit of **₹549.33 Lakhs** only through e-portal of MoEF & CC as provided in the <http://parivesh.nic.in>, and submit the original proof with seal and signature of the issuing Bank to this office for needful.

Further the User Agency will bear additional cost, if any, towards enhancement of wage rate and escalation of price of materials at the time of implementation of this plan. In case of deviation, it will be dealt as per law for violation of Forest (Conservation) Act'1980, Environment (Protection) Act'1986 and Wildlife (Protection) Act,1972.

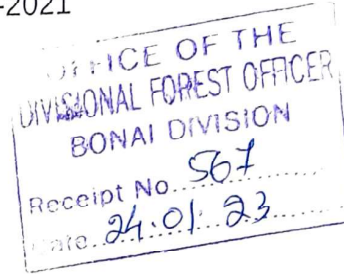

Further the User Agency will bear additional cost, if any, towards enhancement of wage rate and escalation of price of materials at the time of implementation of this plan. In case of any deviation, it will be dealt as per law for violations of Forest (Conservation) Act, 1980, Environment (Protection) Act, 1986 and Wildlife (Protection) Act, 1972.
