With reference to the letter cited  $above_r$  it is to inform you that, the Hon'ble Supreme Court has directed the MoEF &CC for upward revision of Net Present Value (NPV) rate in compliance of order dated.28.03.2008 in writ petition (Civil) No.202 of 1996 in the matter of T.N.Godavarman Thirumalpad Vrs Union of India & Ministry Guideline dated.05.02.2009, you are liable to pay differential cost of Net Present Value (NPV) against the diverted forest land over 41.725 ha vide letter under reference.
