Wherein, the Government of India, MoEF & Climate Change, Chennai vide reference has accorded **in-principle (Stage-I)** approval under section (2) of Forest (Conservation) Act, 1980 for diversion of **1.904 Ha** of Forest Land in Bellampally division - for construction of 11 KV transmission line for the release of 1 No. 96 HP NDS load to Water Grid department for 24 Hrs supply from existing Tandur MHQ feeder in Tandur Mandal in favour of TSNPDCL, subject to fulfillment of certain condition stipulated in the G.O.

Further, the User Agency is requested to comply with the following accordance with the Government of India instructions issued vide F.No.7-23/2012-FC, Dt.24.07.2013 communicated vide PCCF's Rc.No.45921/2001-F4, Dt.23.08.2013 and publish the orders at the cost of the project proponent.

1. Publish the entire forest clearance granted in verbatim along with the conditions and safe-guards imposed by the Central Government in two widely circulated daily newspapers, one in vernacular language and the other in English language, so as to make people aware of the permission granted to the project proponent for use of forest land for non-forest purpose.
2. The copies of the Forest Clearance should also be submitted to the Head of local bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same in 30 days from the date of receipt of this reference.

Further, it is also requested to furnish the **copies of Paper clippings about the publishing of forest Clearance etc.**, as instructed by the Prl. Chief Conservator of Forests TS Hyderabad vide reference 4th cited above.

Therefore, it is requested to refer all the references in connection with this case at utmost care and furnish the required information / condition wise compliance report along with plan for condition No.17 as called in this case urgently for taking further course of action.

This should be attended top priority.
