With reference to the aforementioned letter on the captioned subject the Principal Chief Conservator of Forests, (Wildlife) & CWLW, Odisha, Bhubaneswar has approved the Site Specific Wildlife Conservation Plan for the above project with a financial outlay of Rs. 508.86 lakh out of which Rs. 410.76 lakh (Rs. 370.60 lakh on dt. 25.07.2019 + Rs. 40.16 lakh on dt. 13.11.2020) has already been deposited in Ad-hoc CAMPA Account. Now, the Principal Chief Conservator of Forests, (Wildlife) & CWLW, Odisha, Bhubaneswar has instructed to raise demand with the user agency for deposit of total cost of Rs. 508.86 lakh vide his letter No. 7019/WL dated 26.07.2021.
