Reg: Grant of NOC by the concerned Gram Sabha of village Mugdara towards compliance of the

Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Right) Act 2006 in connection with renewal of Forest Clearance of the Mugdara Dolomite Mines Lease area over 19.223 hect. in the District of Mandla (M.P) of M/s OCL India Limited, Rajgangpur, Odisha.

We would like to submit as under on the captioned subject.

Dear Sir,

We have applied renewal of forest clearance through Form - B over MOEF, Parivesh portal of our above Mining Lease over 19.223 ha.(entire area falls under forest area). We are also going to apply for Environment Clearance in the same platform of MOEF.

As required under the Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Right) Act 2006, a NOC from the concerned Palli Sabha of village Mugdara is required by way of resolution in connection with renewal of forest clearance, based on which necessary certificate is to be issued by the Collector, Mandla being the Chairperson of the District Level Committee as desired by APPCF, Bhopal vide their letter no F/1/FP/MP/MIN/43378/2029/196 & 4018 dated 13/01/2020 & 26/12/2019 respectively

The entire Mining Lease area of our Mugdara Dolomite Mines falls under forest lands under Mugdara Gram Panchayat under Sub-Divisional Level Committee as defined in sub sec.(3) of Sec.6 of the above Act. NOC from Palli sabha/ Gram sabha is also a mandatory requirement as per SEIAA, Madhya Pradesh notification No 1216/SEIAA/2019 dated 20/06/2019.

You are therefore requested to please advise suitably to the concerned BDO/Tahsildar for their onward advising to the Sarpanch to place the proposal in the Palli Sabha and issue an NOC by way of necessary resolution of the concerned Palli Sabha, indicating their written consent for renewal of the forest clearance of the said mines & send the same to concerned BDO/Tahsildar to certify the same & send upward to the Collector, Mandla who will issue the certificate as Chairperson of the District level committee for onward submission to DFO, Mandla.
