



POWER OF ATTORNEY

To enter into Lease Deed in connection with acquiring properties in the state of ^{Uttar Pradesh} on lease for setting up of the said retail outlets and for that purpose to execute lease deeds and leave & license including deeds of confirmation, that may be required in that regard, in such manner and on such terms and conditions as may be decided by the Company.
2. 


And the Company hereby ratify and confirm and agree to ratify and confirm all and whatsoever the said attorney shall lawfully do or cause to be done in or about the premises.






