To sign and execute agreements, applications, correspondences, undertakings, declarations or any other documents or writings for obtaining permission, clearances for Right of Way, establishment of underground telegraph infrastructure, ducts, Optical Fibre Cable, poles for aerial cabling or any other telecommunication facilities as may be required from time to time.
- 2. To accept notices or services of writ of summons or other legal process that may be served upon the Company and to appoint Advocates/Counsels and to declare and affirm all plaints, written statements, applications, petitions, affidavits and other necessary documents on behalf of the Company.
- 3.
