**Sub: Minutes of the 36<sup>th</sup> Meeting of Standing Committee of NBWL.**

Sir,


During the 36<sup>th</sup> Meeting of Standing Committee of NBWL held on 4<sup>th</sup> November 2015 under the Chairmanship of Hon'ble Minister of State (Independent Charge) for Environment, Forests and Climate Change, the following proposal pertaining to your State was considered. The relevant portion of the decision taken in respect of the proposal is reproduced below:

- "1. Request for reconsideration of the proposal of Marine Sanctuary area 4.90 ha of block No.48 "Rozi nar nu jungle" for Tugs/Barges for manufacturing, repairing and maintenance by Hind Marine Works, Jamnagar, Gujarat.

*The member secretary briefed the Committee on the proposal and mentioned that the proposed area was being utilized by the user agency for manufacturing, repairing and maintenance of tugs and barges facility till 2011. Representative of CWLW, Gujarat stated that they have no objection to the proposal and that the area is forest area located in the Marine Sanctuary. After discussions, the Committee decided to recommend the proposal along with the conditions prescribed by the CWLW, Gujarat and asked the user agency to obtain Forest Clearance and CRZ clearance afresh."*

The above recommendation(s) are subject to the existing directives of Hon'ble Supreme Court and provisions of Forests (Conservation) Act, 1980.


