Subject: Grant of Mining Lease in the district of Sundargarh.
Read: Application presented on 26.2.1971 by M/s. I.S.Ltd, Rourkela for grant of Mining Lease for Iron Ore in Toda L.P. over an area of 93.53 acres in the district of Sundargarh.

ORDER

Whereas M/s.I.S.Ltd., Rourkela, have applied to the State Govt. for grant of a Mining Lease by their application read above;

Whereas the mineral in the land in respect of which the mining lease has been applied for belongs to Govt. and the land is at their disposal.

Whereas the applicant holds a valid Certificate of approval from the State Government;

Whereas the applicant being a limited company is incorporated or registered in India:

Whereas the applicant by himself or with any person joint in interest with him does in respect of Iron ore or related group of minerals held such area in the State as with the area over which the mining lease has now been asked for exceed ten square miles in the aggregate.

Whereas the Govt. of India have conveyed their approval to the grant of Mining Lease under Section 5(2) of the Mines and Minerals (Regulation and Development) Act, 1957 and have relaxed the provision of Section 5(1)(b) of the Act and also in exercise of the powers conferred under rule 5 of the Mineral Concession Rules, 1960 have directed the State Govt. to take into consideration this application and pass appropriate orders within four months.

Whereas the party was asked in mining and geology department letter No. 12564 Mg. dated 6.12.1972 to accept the terms and conditions under which the M.L. was proposed to be considered for grant and the party in his letter No. OMRP/11(2-120)/11299 dt. 19.12.72 accepted these conditions,

Therefore, the State Govt. are hereby pleased to order that a M.L. in respect of the land over 93.53 acres be granted to M/s. I.S.L. Rourkela subject to the conditions laid down in the State Govt. letter No. 12564/MG. dt. 6.12.72. The party should comply with all the terms and conditions including furnishing of a surveyed map and description within 3 months from the date of this order to the Collector, Sundargarh.

Sub:- Revocation of grant orders for M.L.in the district of Keonjhar.
Road:- Govt.Proceedings No.537/MG.dt.16.1.73 & Order No.9738/MG.dt.11.10.1974.

ORDER :-

Whereas M/s.H.S.Ltd.Rourkela had applied for a Mining Lease for Iron Ore over an area of 93.53 Acres in Toda R.F.of Sundergarh District videtheir application dt.26.2.71,
Whereas an available area of 93.53 acres was granted in their favour in Government Proceedings No.537/MG.dt.16.1.73;
Whereas after survey and demarcation the area came to 94.35 Acres instead of 93.53 Acres and a portion of the area of 30.16 acres or 12.2012 Hec of Block 'A' came in the district of Keonjhar ;
Whereas the execution order was issued in Government letter No.9738/MG.dt.11.10.74 and the party was asked therein to execute two separate lease deeds with Keonjhar and Sundergarh Collectors for the respective lease areas within their districts ;
Whereas the party has executed the lease deed on 17.1.75 with Collector, Sundergarh for the area of 25.981 Hectares coming within the said district and for the rest of the area of 12.2012 hectares coming within the Keonjhar district, they have intimated in their letter No.OMQP/11(2-120)/6301 dt.30.7.75 that they are not interested for the same ;
Now, therefore, the State Government are pleased to revoke partially the order of grant of the M.L.issued in Government Proceeding No.537/MG.dt.16.1.73 to the extent of 12.2012 Hectares of land laying in Keonjhar district so as to limit the grant of the M.L.to 25.981 hectares coming within the Sundergarh District only for which the party has already executed a lease deed on 17.1.75.
