- 1 The work of erection of boundary stone at an interval of 20 meters along the proposed Pipe line should be completed at an early date and furnish the details on its completion.
- 2 As per the instructions of the Principal Chief Conservator of Forests (Head of Department) Chennai reference cited and guidelines of the Govt. of India, the Net Present Value (NPV) of Eco Class 3 for open Forest type is Rs. 6,26,000 per Ha. Hence, the diversion of 0.050735 Ha. the NPV amount of Rs.31,760/- (Rupees Thirty One

Thousand Seven Hundred and Sixty only) should be deposited in the concerned Head of account after only generating challan throw the Ministries Web portal.

- 4 The user agency should furnish and undertaking to effect that to pay the cost towards lease rent as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted of the above project in future for the entire project period.
- The user agency should furnish and undertaking to the total area utilized for the project shall not exceed 0.050735 ha comprising water supply pipeline to a length of 563.72m and width is 0.90m and after completion of underground laying of pipeline, area should be restored to its normalcy.

The City Engineer, Coimbatore City Municipal Corporation, Coimbatore is requested to furnish the compliance report on full filling the conditions stipulated by the Government of India to obtain the stage – II approval from them.
