सा.का.नि. 717(अ).—केन्द्रीय सरकार, खान और खनिज (विकास और विनियमन) अधिनियम, 1957 (1957 का 67) की धारा 13 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए खनिज रियायत नियम, 1960 का और संशोधन करने के लिए निम्नलिखित नियम बनाती है, अर्थात्:-

1. संक्षिप्त नाम और प्रारंभ.—(1) इन नियमों का संक्षिप्त नाम खनिज रियायत (संशोधन) नियम, 2021 है ।

(2) इन नियमों में अन्यथा उपवंधित के सिवाय, ये उनके राजपत्र में प्रकाशन की तारीख को प्रवृत्त होंगे ।

2. खनिज रियायत नियम, 1960 (जिसे इसमें इसके पश्चात् मूल नियम कहा गया है) के नियम 2 के उपनियम (1) के खंड (vii) के पश्चात् निम्नलिखित खंड अंत:स्थापित किया जाएगा, अर्थातु:--

'(viiक) "खान का परिचालन" से पट्टा क्षेत्र के खनिजीकृत जोन से विस्फोटन, उत्खनन, कर्तन या खुरचन के पश्चात् प्राप्त अपनी प्राकृतिक अवस्था में कच्ची, अप्रसंस्कृत या असम्मिलित सामग्री अभिप्रेत है ; '

3. मूल नियमों में नियम 24ख के पश्चात् निम्नलिखित नियम अंत:स्थापित किया जाएगा, अर्थात्:--

"24ग. सरकारी कंपनियों या निगमों को प्रदान किए गए खनन पट्टे की अवधि.—

(1) खनिज रियायत (संशोधन) नियम, 2021 के प्रारंभ पर या उसके पश्चात् कोयले या लिग्नाइट के लिए सरकारी कंपनी या निगम को प्रदान किए गए सभी खनन पट्टे 50 वर्ष की अवधि के लिए होंगे ।

[PART II—SEC. 3(i)]

(2) खनिज रियायत (संशोधन) नियम, 2021 के प्रारंभ से पूर्व कोयले या लिग्नाइट के लिए किसी सरकारी कंपनी या निगम में निहित या उसे प्रदत्त सभी विद्यमान खनन पट्टे 50 वर्ष के लिए या 31 मार्च, 2030 तक, इनमें से जो भी पश्चात्वर्ती हो, प्रदत्त किए गए समझे जाएंगे ।

(3) राज्य सरकार, इस संबंध में खनन पट्टे के अवसान से कम से कम तीन मास पूर्व किसी सरकारी कंपनी या निगम द्वारा किए गए आवेदन पर खनिज पट्टे को एक समय में बीस वर्ष की और अवधि के लिए वढ़ाएगी:

परंतु राज्य सरकार विहित समय सीमा के पश्चात् विस्तार के लिए आवेदन में देरी को माफ कर सकेगी:

परंतु यह और कि किसी सरकारी कंपनी या निगम को खनन पट्टे के अवधि का विस्तार नहीं प्रदान किया जाएगा जो निविदा के माध्यम से चयनित की गई है ।

(4) यदि राज्य सरकार द्वारा उपनियम (3) में उल्लिखित समय के भीतर खनन पट्टे के विस्तार के लिए किया गया कोई आवेदन पट्टे के अवसान की तारीख से पूर्व निपटाया नहीं जाता है, तो उस पट्टे की अवधि उस पर राज्य सरकार द्वारा आदेश पारित किए जाने तक विस्तृत हुई समझी जाएगी ।

(5) सरकारी कंपनी या निगम द्वारा खनन पट्टें के नवीकरण के लिए किए गए सभी आवेदन जो खान और खनिज (विकास और विनियमन) संशोधन अधिनियम, 2021(2021 का 16) के आरंभ की तारीख पर लंबित थे, खनन पट्टे की अवधि के विस्तार के लिए आवेदन समझे जाएंगे और उपनियम (3) के उपबंधों के अनुसार निपटाए जाएंगे ।" ।

4. मूल नियमों के नियम 27 के पश्चात् निम्नलिखित नियम अतः स्थापित किया जाएगा , अर्थात्:--

"27कु. आवद्ध खान के पट्टाधारी द्वारा कोयले या लिग्नाइट के विक्रय की रीति.—(1) कोई पट्टाधारी जहां आबद्ध प्रयोजन के लिए कोयले या लिग्नाइट का उपयोग किया जाता है, खान से सेंबद्ध एंड-यूज संयंत्र की अपेक्षाओं को पूरा करने के पश्चात् किसी वित्तीय वर्ष में उत्पादित कोयले या लिग्नाइट की धारा 8 की उपधारा (5) के अधीन यथा अनुज्ञात कुल मात्रा के ऐसे प्रतिशत तक कोयला या लिग्नाइट विक्रय कर सकेगा।

स्<mark>पष्टीकरण 1.—</mark>इस नियम के प्रयोजन के लिए यह स्पष्ट किया जाता है कि किसी वित्तीय वर्ष के लिए खान के संबद्ध एंड-यूज संयंत्र की अपेक्षा उस वित्तीय वर्ष या उसके किसी भाग में उक्त संयंत्र द्वारा उपभोग किए गए कोयले या लिग्नाइट की वास्तविक मात्रा होगी ।

स्पष्टीकरण 2.—इस नियम के प्रयोजन के लिए उत्पादित, वितरित, एंड-यूज संयंत्र से संबद्ध उपयोग किए गए कोयले या लिग्नाइट की मात्रा और वितरित मात्रा पर अतिरिक्त रकम के संदाय का निर्धारण खान के परिचालन आधार पर किया जाएगा

स्पर्ष्टीकरण 3.—अपशिष्ट, अग्राह्य या मिडलिंग का विक्रय इस[्]नियम द्वारा निर्बंधित नहीं होगा ।

(2) धारा 8 की उपधारा (5) के अनुसार विक्रीत कोयले या लिग्नाइट की मात्रा के लिए पट्टाधारी, राज्य सरकार को स्वामिस्व का संदाय करते समय अधिनियम की छठी अनुसूची में यथा विनिर्दिष्ट अतिरिक्त रकम का संदाय करेगा, जो जिला खनिज फाउंडेशन और राष्ट्रीय खनिज खोज न्यास को स्वामिस्व या संदाय अन्य कानूनी संदाय या निविदा दस्तावेज अथवा नील<mark>ामी</mark> प्रीमियम में विनिर्दिष्ट संदाय, जहां कहीं लागू हो, के अतिरिक्त होगा ।

(3) पट्टाधारी पूर्व वित्तीय वर्ष में किए गए विक्रय के लिए किसी वित्तीय वर्ष की समाप्ति के एक माह के भीतर नामनिर्दिष्ट प्राधिकारी, कोयला मंत्रालय, कोयला नियंत्रण संगठन और राज्य सरकार को प्ररूप **द** में स्वघोषणा प्रस्तुत करेगा ।

(4) किसी कंपनी या निगम को आबंटित कोयले की खानों से कोयले का विक्रय अनुज्ञात नहीं होगा, जिन्हें टैरिफ के लिए प्रतियोगिता वोली के आधार पर शक्ति परियोजना (जिसके अंतर्गत अल्ट्रा मेगा पावर प्रोजेक्ट भी है) प्रदान किए गए हैं ।"

स्पष्टीकरण.—इस नियम के प्रयोजन के लिए यह स्पष्ट किया जाता है कि इस नियम में यथा विनिर्दिष्ट कोयले या लिग्नाइट के विक्रय के लिए उपवंध केन्द्रीय सरकार के साथ पट्टाधारी द्वारा किए गए संबंधित करार में विहित पात्रता शर्तों और कार्य कुशलता प्राचलों को प्रभावित नहीं करेंगे ।

5. मूल नियमों के नियम 28 के स्थान पर निम्नलिखित नियम रखा जाएगा, अर्थात्:--

"28. पट्टों का व्यपगमन.—(1) जहां खनन पट्टे के निष्पादन की तारीख से दो वर्ष के भीतर उत्पादन और प्रेषण प्रारंभ नहीं हुआ हो या उत्पादन या प्रेषण प्रारंभ होने के पश्चात् दो वर्ष की सतत अवधि के लिए समाप्त हो गया हो, खनन पट्टा यथा स्थिति पट्टे के निष्पादन की तारीख से या उत्पादन और प्रेषण की समाप्ति से दो वर्ष की अवधि के अवसान पर व्यपगत हो जाएगा ।

(2) खनन पट्टे का व्यपगमन राज्य सरकार द्वारा जारी किए गए आदेश के माध्यम से अभिलिखित किया जाएगा और पदाधारी को भी संसुचित किया जाएगा।

(3) जहां पट्टाधारी खनन अनुज्ञप्ति के निष्पादन की तारीख से दो वर्ष की अवधि के भीतर उत्पादन और प्रेषण प्रारंभ करने में असमर्थ है या उसके नियंत्रण से बाहर के कॉरणों से उत्पादन और प्रेषण समाप्त हो जाता है, वह राज्य सरकार को उक्त दो वर्ष की अवधि के अवसान से कम से कम तीन मास पहले उसका कारण दर्शित करते हुए ऐसी दो वर्ष की अवधि को एक वर्ष से अनधिक की अतिरिक्त अवधि तक बढ़ाने का अनुरोध करते हुए एक आवेदन प्रस्तुत कर सकेगा:

परंतु जहां पट्टाधारी उपरोक्त नियत समय के भीतर आवेदन करने में असफल रहता है वहां दो वर्ष की समाप्ति पर पट्टा व्यपगत हो जाएगा ।

(4) उपनिर्यम (3) के अधीन किए गए आवेदन में निम्नलिखित विनिर्दिष्ट किया जाएगा—

(क) वह कारण, जिनसे पट्टाधारी के लिए खनन संक्रियाएं करने या उत्पादन और प्रेषण को जारी रखना असंभव हो गया;

(ख) वह रीति जिसमें ऐसे कारण पंट्टाधारी के नियंत्रण के बाहर है;

(ग) वह कदम^दजो पट्टाधारी द्वारा ऐसे कारणों के प्रभाव को कम करने के लिए उठाए गए हैं; और

(घ) चाहे गए विस्तार् की अवधि ।

(5) उपनियम (3) के अधीन किए गए प्रत्येक आवेदन के साथ दो सौ रुपए की फीस सलग्न होगी ।

(6) राज्य सरकार, आवेदन की परीक्षा करने के पश्चात्, उपधारा (3) के अधीन किए गए आवेदन की प्राप्ति की तारीख से या उस तारीख से, जिसको खनिज पट्टा अन्यथा व्यपगत हो जाएगा, इनमें से जो भी पहले हो, से तीन मास की अवधि के भीतर ऐसा अनुरोध को स्वीकार करते हुए या खारिज करते हुए कोई आदेश पारित करेगी:

परंतु ऐसा खनिज पट्टा उत्पादन और प्रेषण करने में विफल होने पर या एक वर्ष के लिए बढ़ाई गए अवधि के भीतर उत्पादन और प्रेषण जारी रखने में असक्षमता पर व्यपगत हो जाएगा:

परंतु यह और कि ऐसा विस्तार पूरी पट्टा अवधि के दौरान एक बार से अधिक नहीं प्रदान की जाएगी ।

(7) राज्य सरकार ऐसा आदेश अभिलिखित करने या जारी करने के पंद्रह दिन के भीतर उपनियम (2) के अधीन अभिलिखित या उपनियम (6) के अधीन जारी आदेश कोयला नियंत्रण संगठन, नामनिर्दिष्ट प्राधिकारी और कोयला मंत्रालय को संसूचित करेगी। "।

6. मूल नियमों के नियम 28क का लोप किया जाएगा ।

7. मूल नियमों के नियम 64ख के स्थान पर निम्नलिखित नियम रखा जाएगा, अर्थात्:--

"64ख़ प्रसंस्करण के अधीन रहते हुए खनिजों के मामले में रायल्टी के संदाय भुगतान करना और भारित करना- पट्टा क्षेत्र के भीतर या वाहरं इसके प्रसंस्करण को विचार में लाए बिना अप्रसाधित अयस्क खनिजकोयला या लिग्नाइट पर रायल्टी , भारित की जाएगी:

परंत रायल्टी पट्टे पर दिए गए क्षेत्र के भीतर से प्रेषण या उपभोग के समय देय होगी ।"

8. मूल नियमों में, नियम 64ग का लोप किया जाएगा।

9. मूल नियमों में, अनुसूची | में, प्ररुप थ के पश्चात् निम्नलिखित प्ररुप को अंतःस्थापित किया जाएगा, अर्थात् :-

केन्द्रीय सरकार, खान और खनिज (विकास और विनियमन) संशोधन अधिनियम, 2021 (2021 का 16) के माध्यम से अंतःस्थापित खान और खनिज (विकास और विनियमन) अधिनियम, 1957 की धारा 8 की उपधारा (4) को तदनुसार विद्यमान खान के पट्टों की अवधि को विहित करने के लिए सरकारी कंपनी या निगम के मामलों में खान के पट्टों की अवधि को विस्तार करने के लिए सशक्त करती है, विद्यमान पट्टों की अवधि को नियम 24ग की उपधारा (2) में विहित किया गया है और खान के पट्टों के नवीकरण के लिए लंबित आवेदनों को नियम 24ग के उपनियम (5) में खान के पट्टों की अवधि के विस्तार के लिए किया गया आवेदन समझा जाएगा । यह प्रमाणित किया जाता है कि किसी भी व्यक्ति पर इन नियमों के माध्यम से भूतलक्षी प्रभाव देने से प्रतिकूल प्रभाव नहीं पड़ेगा।

MINISTRY OF COAL NOTIFICATION

New Delhi, the 1st October, 2021

G.S.R. 717(E).-In exercise of powers conferred by Section 13 of the Mines and Minerals Development and Regulation) Act, 1957 (67 of 1957), the Central Government hereby makes the following rules further to amend the Mineral Concession Rules, 1960, namely:-

1. Short title and commencement.-(1) These rules may be called the Mineral Concession (Amendment) Rules, 2021.

(2) Save as otherwise provided in these rules they shall come into force on the date of their publication in Gazette of India.

2. In the Mineral Concession Rules, 1960, (hereinafter referred to as the principal rules), in rule 2, in subrule (1), after clause (vii), the following clause shall be inserted, namely:-

(viia) "run-of-mine" means the raw, unprocessed or uncrushed material in its natural state obtained after blasting, digging, cutting or scraping from the mineralised zone of a lease area;'.

3. In the principal rules, after rule 24B the following rule shall be inserted, namely:-

- "24C. Period of mining lease granted to Government companies or corporations.---
 - (1) All mining leases granted on or after the commencement of the Mineral Concession (Amendment) Rules, 2021 to a Government company or corporation for coal or lignite shall be for a period of fifty years.
 - (2) All subsisting mining leases vested or granted to a Government company or corporation before commencement of the Mineral Concession (Amendment) Rules, 2021 for coal or lignite shall be deemed to have been granted for fifty years or till 31st March 2030, whichever is later.
 - (3) The State Government, upon an application made to it in this behalf by the Government company or corporation at least three months prior to the expiry of the mining lease, shall extend the period of the mining lease for a further period of twenty years at a time:

Provided that the State Government may condone the delay in application for extension made after the prescribed time limit:

Provided further that no extension of period of mining lease shall be granted to a Government company or corporation that has been selected through auction.

- (4) If an application for extension of mining lease made within the time mentioned in sub-rule (3) is not disposed of by the State Government before the date of expiry of the lease, the period of that lease shall be deemed to have been extended till the State Government passes an order on the same.
- (5) All applications made by a Government company or corporation for renewal of mining lease which were pending as on the date of commencement of the Mines and Minerals (Development and Regulation) Amendment Act, 2021 (16 of 2021) shall be deemed to be applications for extension of the period of the mining lease and shall be disposed of in accordance with the provisions of sub-rule (3).".

4. In the principal rules, after rule 27, the following rule shall be inserted, namely:-

"27A. Manner of sale of coal or lignite by the lessee of a captive mine.— (1)Any lessee may, where coal or lignite is used for captive purpose, sell coal or lignite up to such per cent. of the total coal or lignite produced in a financial year, as allowed under sub-section (5) of section 8, after meeting the requirement of the end use plant linked with the mine.

Explanation 1.- For the purpose of this rule it is clarified that the requirement of the end use plant linked with the mine for a financial year shall be the actual quantity of coal or lignite consumed in the said plant in that financial year or a part thereof.

Explanation 2.- For the purpose of this rule, quantity of coal or lignite produced, sold, utilised in linked end-use plant and the payment of additional amount on the quantity sold shall be assessed on run-of-mine basis.

Explanation 3.-Sale of any tailings, rejects or middlings shall not be restricted by this rule.

(2) For the quantity of coal or lignite sold in accordance with sub-section (5) of section 8, the lessee shall pay to the State Government, at the time of payment of royalty, an additional amount as specified in the Sixth Schedule of the Act, which shall be in addition to royalty or payment to the District Mineral Foundation and National Mineral Exploration Trust or any other statutory payment or payment specified in the tender document or the auction premium, wherever applicable.

(3) Within one month of the end of a financial year, for sale made in the previous financial year, the lessee shall submit to the Nominated Authority, Ministry of Coal, Coal Controller's Organisation and to the State Government, a self-declaration in Form R.

(4) Sale of coal shall not be allowed from the coal mines allotted to a company or corporation that has been awarded a power project on the basis of competitive bid for tariff (including Ultra Mega Power Projects)."

Explanation.-For the purpose of this rule, it is clarified that the provision for sale of coal or lignite as prescribed in this rule shall not affect the eligibility conditions and efficiency parameters prescribed in the respective agreements entered into by the lessee with the Central Government.

5. In the principal rules, for rule 28, the following rule shall be substituted, namely:-

"28. Lapsing of Leases.— (1) Where production and dispatch has not commenced within a period of two years from the date of execution of the mining lease or is discontinued for a continuous period of two years after commencement of production or dispatch, the mining lease shall lapse on the expiry of the period of two years from the date of execution of the lease or as the case may be, discontinuance of the production and dispatch.

(2) The lapsing of the mining lease shall be recorded through an order issued by the State Government and shall also be communicated to the lessee.

(3) Where a lessee is unable to commence the production and dispatch within a period of two years from the date of execution of the mining lease or discontinuation of production and dispatch for reasons beyond his control, he may submit an application to the State Government, requesting for an extension of such period of two years by a further period not exceeding one year, explaining the reasons for the same, at least three months before the expiry of such period of two years:

Provided where the lessee has failed to make the application within the time stipulated above, the lease shall lapse on expiry of the period of two years.

(4) Application made under sub-rule (3) shall specify—

- (a) the reasons on account of which it will not be possible for the lessee to undertake mining operations or continue production and dispatch;
- (b) the manner in which such reasons are beyond the control of the lessee;
- (c) the steps that have been taken by the lessee to mitigate the impact of such reasons; and
- (d) the period of extension sought.

(5) Every application under sub-rule (3) shall be accompanied by a fee of two hundred rupees.

(6) The State Government shall, after examining the application, pass an order, within a period of three months from the date of receipt of the application made under sub-rule (3) or the date on which the mining lease would have otherwise lapsed, whichever is earlier, either granting or rejecting such request:

Provided that such mining lease shall lapse on failure to undertake production and dispatch or inability to continue production and dispatch within the extended period of one year:

Provided further that such extension shall not be granted for more than once during the entire period of lease.

(7) The State Government shall communicate to the Coal Controller's Organisation, Nominated Authority and Ministry of Coal the order recorded under sub-rule (2) or issued under sub-rule (6) within fifteen days of recording or issuing of such order.".

6. In the principal rules, rule 28A shall be omitted.


7. In the principal rules, for rule 64B, the following rule shall be substituted, namely:-

"64B. Charging and instance of payment of royalty in case of minerals subjected to processing.— The royalty shall be charged on run-of-mine coal or lignite irrespective of its processing within or outside the leased area:

Provided that the royalty shall be payable at the time of dispatch from or consumption within the leased area.".

8. In the principal rules, rule 64C shall be omitted.

9. In the principal rules, in Schedule I, after Form Q, the following Form shall be inserted, namely:-



The following Bill was introduced in Lok Sabha on the 11th May, 1973:-

Fill No 38 of 1973

A Bill to provide for the acquisition and transfer of the right, title and interest of the owners in respect of the coal mines specified in the Schedule with a view to re-organising and reconstructing such coal mines so as to ensure the rational, co-ordinated and scientific development and utilisation of coal resources consistent with the growing requirements of the country, in order that the ownership and control of such resources are vested in the State and thereby so distributed as best to subserve the common good, and for matters connected therewith or incidental thereto.

BE it enacted by Parliament in the Twenty-fourth Year of the Republic of India as follows :---

CHAPTER I

Preliminary

1. (1) This Act may be called the Coal Mines (Nationalisation) Act, 1973.

(2) The provisions of sections 30 and 31 shall come into force at once and the remaining provisions of this Act shall be deemed to have come into force on the 1st day of May, 1973.

2. In this Act, unless the context otherwise requires,-

(a) "appointed day" means the 1st day of May, 1973;

(b) "coal mine" means a mine in which there exists one or more seams of coal;

Short title and commencement

Definitions

(c) "company" means a company as defined in section 3 of the Companies Act, 1956, and includes a foreign company within the meaning of section 591 of that Act;

(d) "Commissioner" means the Commissioner of Payments appointed under section 17;

(e) "Custodian" means the Custodian appointed under sub-section (2) of section 11, to take over, or carry on, the management of a coal mine;

(f) "Government company" has the meaning assigned to it by section 617 of the Companies Act, 1956;

1 of 1956.

(g) "managing contractor" means the person, or body of persons, who, with the previous consent, in writing, of the State Government, has entered into an arrangement, contract or understanding, with the owner of a coal mine under which the operations of the coal mine are substantially controlled by such person or body of persons;

(h) "mine" means any excavation where any operation for the purpose of searching for or obtaining minerals has been or is being carried on, and includes—

(i) all borings and bore holes;

(ii) all shafts, whether in the course of being sunk or not;

(iii) all levels and inclined planes in the course of being driven:

(iv) all open cast workings;

(v) all conveyors or aerial ropeways provided for bringing into or removal from a mine of minerals or other articles or for the removal of refuse therefrom;

(vi) all lands, buildings, works, adits, levels, planes, machinery and equipments, instruments, stores, vehicles, railways, tramways and sidings in, or adjacent to, a mine and used for the purposes of the mine;

(vii) all workshops (including buildings, machinery, instruments, stores, equipment of such workshops and the lands on which such workshops stand) in, or adjacent to, a mine and used substantially for the purposes of the mine or a number of mines under the same management;

(ix) all power stations in a mine or operated primarily for supplying electricity for the purpose of working the mine or a number of mines under the same management;

(x) all lands, buildings and equipments belonging to the owner of the mine, and in, adjacent to or situated on the surface of, the mine where the washing of coal obtained from the mine or manufacture, therefrom, of coke is carried on;

(xt) all lands and buildings [other than those referred to in subclause (x)], wherever situated, if solely used for the location of the management, sale or liaison offices, or for the residence of officers and staff. of the mine;

	(xii) all other fixed assets, movable and immovable, belonging to the owner of a mine, wherever situated, and current assets, belonging to a mine, whether within its premises or outside, and also any money lawfully due to such owner in relation to the mine in respect of any period prior to the appointed day.

CHAPTER II

ACQUISITION OF THE RIGHTS OF OWNERS OF COAL MINES

3. (1) On the appointed day, the right, title and interest of the owners in relation to the coal mines specified in the Schedule shall stand transferred to, and shall vest absolutely in, the Central Government free from all incumbrances.

(2) For the removal of doubts, it is hereby declared that if, after the appointed day, the existence of any other coal mine comes to the knowledge of the Central Government, the provisions of the Coal Mines (Taking Over of Management) Act, 1973, shall, until that mine is nationalised by an appropriate legislation, apply to such mine.

4. (1) Where the rights of an owner under any mining lease granted, or deemed to have been granted, in relation to a coal mine, by a State Government or any other person, vest in the Central Government under section 3, the Central Government shall, on and from the date of such vesting, be deemed to have become the lessee of the State Government or such other person, as the case may be, in relation to such coal mine as if a mining lease in relation to such coal mine had been granted to the Central Government and the period of such lease shall be the entire period for which such lease could have been granted by the State Government or such

Central Government to be the lessee of the State Government other person under the Mineral Concession Rules, and thereupon all the rights under such mining lease, including surface, underground and other rights granted to the lessee shall be deemed to have been transferred to, and vested in, the Central Government.

(2) On the expiry of the term of any lease, referred to in sub-section (1), such lease shall, if so desired by the Central Government, be renewed, on the same terms and conditions on which the lease was held, immediately before the appointed day, by the lessor, for the maximum period for which such lease can be renewed under the Mineral Concession Rules.

5. (1) Notwithstanding anything contained in sections 3 and 4, the Central Central Gov Government may, if it is satisfied that a Government company is willing to comply, ernment to direct vesting or has complied, with such terms and conditions as that Government may think of rights in fit to impose, direct, by an order in writing, that the right, title and interest of an owner in relation to a coal mine referred to in section 3, shall, instead of continuing to vest in the Central Government, vest in the Government company either on the date of publication of the direction or on such earlier or later date (not being a date earlier than the appointed day), as may be specified in the direction.

> (2) Where the right, title and interest of an owner in relation to a coal mine vest in a Government company under sub-section (1), the Government company shall, on and from the date of such vesting, be deemed to have become the lessec in relation to such coal mine as if a mining lease in relation to the coal mine had been granted to the Government company and the period of such lease shall be the entire period for which such lease could have been granted under the Mineral Concession Rules; and all the rights and liabilities of the Central Government in relation to such coal mine shall, on and from the date of such vesting, be deemed to have become the rights and liabilities, respectively, of the Government company.

> (3) The provisions of sub-section (2) of section 4 shall apply to a lease which vests in a Government company as they apply to a lease vested in the Central Government and references therein to the "Central Government" shall be construed as references to the Government company.

> 6. (1) All property which vests in the Central Government or in a Government company under this Chapter shall, by force of such vesting, be freed and discharged from any trust, obligation, mortgage, charge, lien and all other incumbrances affecting it and any attachment, injunction or decree or order of any court restricting the use of such property in any manner shall be deemed to have been withdrawn.

> (2) Every mortgagee of any property which has vested under this Act in the Central Government or a Government company, and every person holding any charge, lien or other interest in or in relation to any such property shall give, within such time and in such manner as may be prescribed, an intimation to the Commissioner of such mortgage, charge, lien or other interest.

> (3) For the removal of doubts, it is hereby declared that the mortgagee of any property referred to in sub-section (1) or any other person holding any charge, lien or other interest in, or in relation to any, such property shall be entitled to claim, in accordance with his rights and interests, payment of the mortgage money or other dues, in whole or in part, out of the amount specified in relation to such property in the Schedule, but no such mortgage, charge, lien or other interest shall be enforceable against any property which has vested in the Central Government or the Government company.

7. (1) Every liability of the owner, agent, manager or "managing "contractor of a coal mine, in respect of any period prior to the appointed day, shall be the liability of such owner, agent, manager or managing contractor, as the case may be, and shall be enforceable against him and not against the Central Government or the Government company.

(2) For the removal of doubts, it is hereby declared that---

(a) save as otherwise provided elsewhere in this Act, no claim for wages, bonus, royalty, rate, rent, taxes, provident fund, pension, gratuity or any other dues in relation to a coal mine in respect of any period prior to the appointed day, shall be enforceable against the Central Government or the Government company;

(b) no award, decree or order of any court, tribunal or other authority in relation to any coal mine passed after the appointed day, but in relation to any matter, claim or dispute which arose before that day, shall be enforceable against the Central Government or the Government company

(c) no liability for the contravention, before the appointed day, or any provision of law for the time being in force, shall be enforceable against the Central Government or the Government company.

CHAPTER III "

PAYMENT OF AMOUNT

8. The owner of every coal mine or group of coal mines specified in the second column of the Schedule, shall be given by the Central Government, in cash and in the manner specified in Chapter VI, for the vesting in it, under section 3, of the right, title and interest of the owner in relation to such coal mine or group of coal mines, an amount equal to the amount specified against it in the corresponding entry in the fifth column of the Schedule.

9. (1) In consideration of the retrospective operation of the provisions of sections 3, 4 and 5, there shall be given by the Central Government, in cash, to the owner of every coal mine or group of coal mines specified in the Schedule, an amount equal to the amount which would have been, but for the provisions of the said sections 3, 4 and 5. payable to such owner under the Coal Mines (Taking Over of Management) Act, 1973, for the period commencing on the 1st day of May, 1973, and ending on the date on which this Act receives the assent of the President.

(2) In addition to the amount referred to in sub-section (1), there shall be given by the Central Government, in cash, to the owner of every coal mine or group of coal mines specified in the Schedule, simple interest at the rate of four per cent. per annum on the amount specified against such owner in the corresponding entry in the fifth column of the Schedule for the period commencing on the date on which this Act receives the assent of the President and ending on the date on which payment of such amount is made by the Central Government to the Commissioner.

(3) The amounts referred to in sub-section (1) and sub-section (2) shall be $\frac{1}{2}$ in addition to the amount specified in the Schedule.

10. (1) Where, in pursuance of any decree, order or injunction of a court or otherwise, the Central Government or the Custodian appointed under the Coal Mines (Taking Over of Management) Act, 1973, was prevented from taking over the management of any coal mine, the owner of such coal mine shall render, within sixty days from the date on which management of the coal mine is delivered to

(2) If, on examination of the accounts referred to in sub-section (1), any income is found to have been derived by the owner from the coal mine during the period referred to in that sub-section, such income shall be recoverable by the Central Government from the amount payable under section 8 to the owner of such coal mine, and, the debt due to the Central Government on this account shall rank as an unsecured debt.

(3) If no account is rendered by the owner of a coal mine within the period referred to in sub-section (1) or if the Central Government or the Government company has any reason to believe that the account rendered by such owner is incorrect or false in material particulars, the Central Government or the Government company may refer the matter to the Commissioner and thereupon the Commissioner shall determine the income derived by the owner from the coal mine during the period referred to in sub-section (1), and take steps to recover the said income from the amount payable to the owner of the coal mine under section 8, as if the debt due to the Central Government on this account were an unsecured debt.

(4) No mortgage, charge, lien or other incumbrance in relation to a coat mine or any asset thereof shall be binding on the Central Government or the Government company if such mortgage, charge, lien or other incumbrance was created, at any time during the period in which the Central Government or the Custodian was prevented, by any decree, order or injunction of a court or otherwise, from taking over the management of the said coal mine.

CHAPTER IV

MANAGEMENT, ETC., OF COAL MINES

11. (1) The general superintendence, direction, control and management of the affairs and business of a coal mine, the right, title and interest of an owner in relation to which have vested in the Central Government under section 3, shall,—

(a) in the case of a coal mine in relation to which a direction has been made by the Central Government under sub-section (1) of section 5, vest in the Government company specified in such direction, or

(b) in the case of a coal mine in relation to which no such direction has been made by the Central Government, vest in one or more Custodians appointed by the Central Government under sub-section (2),

and thereupon the Government company so specified or the Custodian so appointed, as the case may be, shall be entitled to exercise all such powers and do all such things as the owner of the coal mine is authorised to exercise and do.

(2) The Central Government may appoint an individual or a Government company as the Custodian of a coal mine in relation to which no direction has been made by it under sub-section (1) of section 5

12. (1) On the vesting of the management of a coal mine in a Government company or on the appointment of a Custodian, all persons in charge of the management of such coal mine immediately before such vesting or appointment. shall be bound to deliver to the Government company or the Custodian, as the case may be, all assets, books of account, registers or other documents in their custody relating to the coal mine.

(2) The Central Government may issue such directions as it may deem desirable in the circumstances of the case to the Government company or Custodian as to its or his powers and duties and the Government company or Custodian may also, if it or he so desires, apply to the Central Government at any time for instructions as to the manner in which the management of the coal mine shall be conducted by it or him or in relation to any other matter arising in the course of such management.

(3) The Custodian shall receive from the funds of the coal mine, in relation to which he or it is the Custodian, such remuneration as the Central Government may fix and shall hold office during the pleasure of the Central Government.

13. The Custodian of every coal mine shall maintain the accounts of such A .ounts mine in such manner and under such conditions as may be prescribed.

CHAPTER V

PROVISIONS RELATING TO EMPLOYEES OF COAL MINES

14. (1) Every person who is a workman within the meaning of the Industrial Employment Disputes Act, 1947, and has been, immediately before the appointed day, in the employment of a coal mine shall become, on and from the appointed day, an employee of the Central Government or, as the case may be, of the Government company in which the right, title and interest of such mine have vested under this Act, and shall hold office or service in the coal mine with the same rights to pension, gratuity and other matters as would have been admissible to him if the rights in relation to such coal mine had not been transferred to, and vested in, the Central Government or the Government company, as the case may be, and continue to do so unless and until his employment in such coal mine is duly terminated or until his remuneration, terms and conditions of employment are duly altered by the Central Government or the Government company.

(2) The Central Government or the Government company in which the right. title and interest in relation to a coal mine have vested, may employ, on mutually acceptable terms and conditions, any person who is not a workman within the meaning of the Industrial Disputes Act, 1947, and who has been, immediately before the appointed day, in the employment of a coal mine, and on such employment the said person shall become an employee of the Central Government or the Government company, as the case may be.

(3) Save as otherwise provided in sub-sections (1) and (2), the services of every person employed by the owner or occupier of a coal mine before the appointed day shall stand terminated on and from the specified date.

(4) Notwithstanding anything contained in the Industrial Disputes Act, 1947, or in any other law for the time being in force, the transfer of the services of any officer or other employee of a coal mine to any other mine shall not entitle such officer or other employee to any compensation under this Act or any other law for the time being in force and no such claim shall be entertained by any court, tribunal or other authority.

(5) Where, under the terms of any contract of service or otherwise, an_y person whose services become terminated or whose services become transferred to the Central Government or a Government company by reason of the provisions of this Act is entitled to any payment by way of gratuity or retirement benefits or for any leave not availed of, or any other benefits, such person may enforce his claim against the owner of the coal mine but not against the Central Government or the Government company.

Provident and other funds 15. (1) Where a coal mine has established a providen, tund, superannuation, welfare or other fund for the benefit of its employees, the monies relatable to the employees, whose services have become transferred by or under this Act to the Central Government or a Government company shall, o_{c} , of the monies standing, on the appointed day, to the credit of such provident fund, superannuation, welfare or other fund, stand transferred to, and vest in, the Central Government or the Government company, as the case may be.

(2) The monies which stand transferred, under sub-section (1), to the Central Government or a Government company shall be dealt with by that Government or company, as the case may be, in such manner as may be prescribed.

Superannuation fund, etc., to be distributed to employees whose employment becomes terminated under this Act.

16. Where the employment of an employee stands terminated by reason of subsection (3) of section 14 and such employee is not employed by the owner of the coal mine in any of his other establishments, such owner shall pay to such employee the amount standing at his credit in the provident fund and also pay him the amounts due to him as superannuation, welfare and other benefits admissible to him as if the employee had superannuated or his service with the coal mine had terminated on the day immediately preceding the specified date.

CHAPTER VI

COMMISSIONER OF PAYMENTS

Commissioner of Payments to be appointed.

17. (1) For the purpose of disbursing the amounts payable to the owner of each coal mine or group of coal mines, the Central Government shall appoint such person as it may think fit to be the Commissioner of Payments.

(2) The Central Government may appoint such other persons as it may think fit to assist the Commissioner and thereupon the Commissioner may authorise one or more of such persons to also exercise all or any of the powers exercisable by him under this Act, and different persons may be authorised to exercise different powers.

(3) Any person authorised by the Commissioner to exercise any powers may exercise those powers in the same manner and with the same effect as if they have been conferred on that person directly by this Act and not by way of authorisation.

(4) The salaries and allowances of the Commissioner and oth τ persons appointed under this section shall be defrayed out of the Consolidated Fund of India.

Payment by the Central Government to the Commissioner

18. (1) The Central Government shall, within thirty days from the specified date, pay, in cash, to the Commissioner for payment to the owner of a coal mine, an amount equal to the amount specified against the coal mine in the Schedule and shall also pay to the Commissioner such sums as may be due to the owner of a coal mine under section 9.

(2) In addition to the sum referred to in sub-section (1), the Central Government shall pay, in cash, to the Commissioner, such amount as may become due to the owner of a coal mine in relation to any period, after the appointed day, during which the management of the coal mine remains vosted in the Central Government.

(3) A deposit account shall be opened by the Central Government, in favour of the Commissioner, in the Public Account of India, and every amount paid under this Act to the Commissioner shall be deposited by him to the credit of the said deposit account in the Public Account of India, and thereafter the said deposit account shall be operated by the Commissioner.

(4) Separate records shall be maintained by the Commissioner in respect of each coal mine in relation to which payments have been made to him under this Act.

(5) Interest accruing on the amounts standing to the credit of the deposit account referred to in sub-section (3) shall enure to the benefit of the owners of coal mines.

(6) References in this section to the owner of a coal mine shall, in relation to a group of coal mines specified in the Schedule, be construed as references to the owner of that group of coal mines.

19. (1) The Central Government or the Government company, as the case may be, shall cause the books in relation to each coal mine, the management of which has vested in it under the Coal Mines (Taking Over of Management) Act, 1973, to be closed and balanced as on the date immediately before the appointed day, and shall cause a statement of accounts, as on that day, to be prepared, within such time, in such form and in such manner as may be prescribed, in relation to each such mine in respect of the transactions effected by it during the period for which the management of such coal mine remained vested in it:

Statment of accounts in respect of the period of management by the Central Government, etc.

Provided that where two or more coal mines were owned, before the commencement of this Act, by the same owner, a consolidated statement of accounts may be prepared for all the coal mines owned by such owner.

(2) All amounts received by the Central Government or the Government company after the closure of such accounts shall, where such accounts relate to transactions effected before the appointed day, be included in the said statement of accounts in respect of the coal mine to which the said receipt relates.

(3) The Central Government or the Government company in which the right, title and interest of coal mine stands vested shall be entitled to receive, up to the specified date, to the exclusion of all other persons, any money, due to the coal mine, realised after the appointed day notwithstanding that the realisations pertain to a period prior to the appointed day:

Provided that where such realisations have not been included in the statement of accounts as on the day immediately before the appointed day, a supplementary statement of accounts shall be prepared and furnished, at such intervals as may be prescribed, by the Central Government or the Government company to the owner of the coal mine.

(4) The liabilities of the coal mine (not being liabilities arising out of advances made by the Central Government or the Government company), which could not^e be discharged by the appointed day, may be discharged by the Central Government or the Government company up to the specified date, and every payment so made shall be included in the statement of accounts as on the day immediately before the appointed day, indicating therein the period in relation to which the payments were made:

Provided that the liabilities in relation to the period prior to the appointed day, which have not been discharged on or before the specified date, shall be the liabilities of the owner of the coal mine. 167 G. of I_{-2}

(5) A copy of each statement of accounts prepared under this section shall be delivered by the Central Government or the Government company, as the case may be, to the Commissioner and also to the owner:

Provided that where the number of owners is more than one, only one copy of the statement of accounts shall be given to the owners for the benefit of all of them.

(6) The statement of accounts prepared under this section shall be audited by a person who is qualified to be appointed as an auditor of a company under section 226 of the Companies Act, 1956, and the auditor so appointed shall receive from the funds of the coal mine, such remuneration as the Central Government may fix.

(7) The audit of the statement of accounts shall be conducted in such manner as the Central Government may direct.

20. Every person having a claim against the owner of a coal mine shall prefer such claim before the Commissioner within thirty days from the specified date.

Provided that if the Commissioner is satisfied that the claimant was prevented by sufficient cause from preferring the claim within the said period of thirty days, entertain the claim within a further period of thirty days but not thereafter.

21. (1) Every person employed by the owner of a coal mine or group of coal mines may make a claim to the Commissioner to the effect that the sums deducted under sub section (4) of section 7 of the Coal Mines (Taking Over of Management) Act, 1973, are not sufficient to meet fully the amount of arrears due to him, on the appointed day within the meaning of that Act, from the owner of such coal mine or group of coal mines,—

(a) in relation to a provident fund, pension fund, gratuity fund or any other fund established for the welfare of the persons employed by the owner of a coal mine or group of coal mines, or

(b) as wages,

nd that a sum equal to the deficiency may be recovered from the amount specified in the Schedule against the owner of such coal mine or group of coal mines.

(2) Where a claim is made under sub-section (1), the Commissioner shall determine the extent of the deficiency and shall, after such determination, deduct in the first instance, out of the amount paid to him under section 8, a sum equal t^{0} the extent of the deficiency determined by him under this sub-section.

(3) All sums deducted by the Commissionel under sub-section (2) shall, in accordance with such rules as may be made under this Act, be credited by the Commissioner to the relevant fund or be paid to the persons to whom such sums are due, and on such credit or payment, the liability of the owner in respect of all the amounts of arrears due as aforesaid shall stand discharged

(4) The deductions made by the Commissioner under sub-section (2) shall have priority over all other debts, whether secured or unsecured.

Priority in relation to other claims. 22. (1) Save as otherwise provided in section 21, every secured debt due from the owner of a coal mine or group of coal mines shall have priority over all other debts and shall be paid in accordance with the rights and interests of the secured creditors.

(2) Notwithstanding anything contained in any other law for the time being 'n force, there shall be paid in priority to all other unsecured debts, not being the amounts advanced by the Central Government or the Custodian appointed

(a) all sums due to the State Government including royalty and dead rent;

(b) all amounts due in respect of any compensation or liability for compensation under the Workmen's Compensation Act, 1923, in respect of the death or disablement of any employee of the coal mine unless such mine has, under such contract with insurers as mentioned in section 15 of the said Act, rights capable of being transferred to and vested in, the workmen, and

(c) all sums deducted by the employer from the salary or wages of any workman or other employee for credit to any provident fund, or any other fund established for the welfare of the employees of the coal mine but not deposited to the credit of the said fund

(3) The debts specified in sub-section (2) shall rank equally among thems selves and be paid in tull, unless the assets are insufficient to meet them, in which case they shall abate in equal proportions and be paid accordingly.

23. (1) The Commissioner shall fix a certain date on or before which every claimant shall file the proof of his claim or be excluded from the benefit of the disbursement made by the Commissioner

(2) Not less than fourteen days' notice of the date so fixed shall be given by advertisement in one issue of the daily newspaper in the English language and one issue of the daily newspaper in the regional language as the Commissioner may consider suitable, and every such notice shall call upon the claimant to file the proof of his claim with the Commissioner within the time specified in the advertisement.

(3) Every claimant who fails to file the proof of his claim within the time specified by the Commissioner shall be excluded from the disbursements made by the Commissioner.

(4) The Commissioner shall, after such investigation as may, in his opinion, be necessary and after giving the owner of the coal mine an opportunity of refuting the claim and after giving the claimant a reasonable opportunity of being heard, in writing, admit or reject the claim in whole or in part

(5) The Commissioner shall have the power to regulate his own procedure in all matters arising out of the discharge of his functions including the place or places at which he will hold his sittings and shall, for the purpose of making any investigation under this Act, have the same powers as are vested in a civil court under the Code of Civil Procedure, 1908, while trying a suit, in respect of the following matters, namely—

(a) the summoning and enforcing the attendance of any witness and examining him on oath;

(b) the discovery and production of any document or other material object producible as evidence,

(c) the reception of evidence on affidavits,

(d) the issuing of any commission for the examination of witness.

(6) Any investigation before the Commissioner shall be deemed to be a judicial proceeding within the meaning of sections 193 and 228 of the Indian Penal Code and the Commissioner shall be deemed to be a civil court for the

(7) A claimant who is dissatisfied with the decision of the Commissioner may prefer an appeal against the decision to the principal civil court of original jurisdiction within the local limits of whose jurisdiction the coal mine is situated:

Provided that where a person who is a Judge of a High Court is appointed to be the Commissioner, such appeal shall lie to the High Court for the State in which the coal mine is situated, and such appeal shall be heard and disposed of by not less than two Judges of that High Court.

24. Where, after meeting the claims admitted by him, of secured creditors, and unsecured creditors having priority under sub-section (2) of section 22, the total amount of claims of other unsecured creditors admitted by the Commissioner, does not exceed the total amount of the money credited to the account of a coal mine, every such admitted claim shall be paid in full and the balance, if any, shall be paid to the owner, but where such amount is insufficient to meet in full the total amount of the admitted claims, all such claims shall abate in equal proportions and be paid accordingly.

25. Every amount advanced by the Central Government or the Custodian, as the case may be, for the management of a coal mine during the period in which the management of such coal mine remained vested in the Central Government, shall be recovered from the income derived from the transactions which took place at any time after the commencement of the Coal Mines (Taking Over of Management) Act, 1973, but before the appointed day notwithstanding that such income was derived after the appointed day:

Provided that where such income is insufficient to meet in full the total amount of the advance made by the Central Government or the Custodian for the management of the coal mine, the Central Government may make a claim to the Commissioner for the deficiency and thereupon the claim in respect of such deficiency shall have priority over the claims of all other unsecured creditors of the coal mine including those referred to in sub-section (2) of section 22.

Explanation.—In this section, "Custodian" means the Custodian appointed under the Coal Mines (Taking Over of Management) Act, 1973.

Disbursement of amounts to the owners of coal mines. 26. (1) If out of the monies paid to him in relation to a coal mine or group of coal mines specified in the second column of the Schedule, there is a balance left after meeting the liabilities of all the secured and unsecured creditors, the Commissioner shall disburse such balance to the owner of such coal mine or group of coal mines.

(2) Before making any payment to the owner of any coal mine or group of coal mines under sub-section (1), the Commissioner shall satisfy himself as to the right of such person to receive the whole or any part of such amount, and in the event of there being a doubt or dispute as to the right of the person to receive the whole or any part of the amount, referred to in sections 8 and 9, the Commissioner shall refer the matter to the court and make the disbursement in accordance with the decision of the court.

(3) For the removal of doubts, it is hereby declared that the entries in the fourth column of the Schedule shall not be deemed to be conclusive as to the right, title and interest of any person in relation to any coal mine specified in the corresponding entries in the second column of the Schedule and evidence shall be admissible to establish the right, itle and interest of any person in relation to such coal mine.

(4) In relation to a coal mine the operations of which were, immediately before the taking over of the management of such coal mine under the Coal Mines (Taking Over of Maragement) Act, 1973, under the control of a managing contractor the amount specified in the fifth column of the Schedule against such coal mine shall be apportioned between the owner of the coal mine and such managing contractor in such proportions as may be agreed upon by or between the owner and such managing contractor, and in the event of there being no such agreement, in such proportions as may be determined by the court on a reference made to it by the Commissioner.

(5) Where any machinery, equipment or other property in a coal mine has vested in the Central Government or a Government company under this Act, but such machinery, equipment or other property does not belong to the owner of such coal mine, the amount specified in the fifth column of the Schedule against such coal mine shall, on a reference made to it by the Commissioner, be apportioned by the court between the owner of such coal mine and the owner of such machinery, equipment or other property having due regard to the value of such machinery, equipment or other property on the appointed day.

Explanation.—In this section, "court", in relation to a coal mine, means the principal civil court of original jurisdiction within the local limits of whose jurisdiction the coal mine is situated.

27. Any money paid to the Commissioner which remains undisbursed or un- Undisbursed claimed for a period of three years from the last day on which the disbursement or unclaimed was made, shall be transferred by the Commissioner to the general revenue account be deposited of the Central Government; but a claim to any money so transferred may be preferred to the Central Government by the person entitled to such payment and shall be dealt with as if such transfer had not been made the order, if any, for payment of the claim being treated as an order for the refund of revenue.

CHAPTER VII

MISCELLANEOUS

28. The provisions of this Act shall have effect notwithstanding anything in- Effect of this Act of consistent therewith contained in any other law for the time being in force or in other laws. any instrument having effect by virtue of any law her thin this Act, or in any decree or order of any coust. trizunal or oteera u horivy.

29. (1) Every contract entered into he owner or occupier of any coal mine Contracts to cease to for any service, sale or supply and in force im rediately before the appointed day have effect shall, on and from the expiry of one hundred and twenty days from the appointed unless rational the state of fled by day, cease to have effect unless such contract is, before the expiry of that period, Government, ratified, in writing, by the Central Government and in ratifying such contract the Central Government may make such alterations or modifications therein as it may think fit:

Provided that the Central Government shall not omit to ratify a contract unless it is satisfied that such contract is unduly onerous or has been entered into in bad faith or is detrimental to the interests of the coal mine.

(2) The Central Government shall not omit to ratify a contract or make any alteration or modification therein except after giving to the parties to the contract a reasonable opportunity of being heard and except after recording in writing its reasons for refusal to ratify the contract.

Penalties.

30. Any person who,---

(a) having in his possession, custody or control any property forming part of the undertaking of any coal mine referred to in the Schedule wrongfully withholds such property from the Central Government or the Government company, or

(b) wrongfully obtains possession of, or retains, any property forming part of the undertaking of any coal mine specified in the Schedule or wilfully withholds or fails to furnish to the Central Government or any person specified by that Government, any document relating to such coal mine which may be in his possession, custody or control or fails to deliver to the Custodian any assets, books of account, registers or other documents in his custody relating to the coal mine in respect of which a Custodian has been appointed, or

(c) wrongfully removes or destroys any property of any coal mine or pre'ers any claim under this Act which he knows or has reasonable cause to believe to be false or grossly inaccurate,

shall be punishable with imprisonment for a term which may extend to two years, or with fine which may extend to ten thousand rupees, or with both.

Offences by companies.

31. (1) Where an offence under this Act has been committed by a company, every person who at the time the offence was committed was in charge of, and was responsible to, the company for the conduct of the business of the company as well as the company, shall be deemed to be guilty of the offence and shall be liable to be proceeded against and punished accordingly :

Provided that nothing contained in this sub-section shall render any such person leable to any punishment, if he proves that the offence was committed without his knowledge or that he had exercised all due diligence to prevent the commission of such offence.

(2) Notwithstanding anything contained in sub-section (1), where any offence under this Act has been committed by a company and it is proved that the offence has been committed with the consent or connivance of, or is attributable to, any neglect on the part of any director, manager, secretary or other officer of the company, such director, manager, secretary or other officer shall be deemed to be guilty of that offence and shall be liable to be proceeded against and punished accordingly.

Explanation .-- For the purposes of this section,---

(a) "company" means any body corporate and includes a firm or other association of individuals; and

(b) "director", in relation to a firm, means a partner in the firm.

Mining companies not to be wound up by the court. **32.** No proceeding for the winding up of a mining company, the right, title and interest in relation to the coal mine owned by which have vested in the Central Government or a Government company under this Act or for the appointment of a receiver in respect of the business of the company, shall lie in any court except with the consent of the Central Government.

Delegation of powers.

33. (1) The entral Government may, by notification, direct that all or any of the powers exercisable by it under this Act may also be exercised by any person or persons as may be specified in the notification.

(2) Whonever any delegation of power is made under sub-section (1), the person to whom such power has been delegated shall act under the direction, control and supervision of the Central Government.

34. (1) The Central Government may, by notification, make rules to Power to make rules. carry out the provisions of this Act.

(2) In particular, and without prejudice to the generality of the foregoing power, such rules may provide for all or any of the following matters, namely:---

(a) the manner in which the coal mine shall be managed by a Government company or a Custodian;

(b) the manner in which monies in any provident or other fund referred to in section 15 shall be dealt with;

(c) the form and manner in which the statement of accounts referre to in section 19 shall be prepared;

(d) any other matter which is required to be, or may be, prescribed.

(3) Every rule made by the Central Government under this Act shall be laid, as soon as may be after it is made, before each House of Parliament while it is in session, for a total period of thirty days which may be comprised in one session or in two or more successive sessions, and if, before the expiry of the session immediately following the session or successive sessions aforesaid, both Houses agree in making any modification in the rule or both Houses agree that the rule should not be made, the rule shall thereafter have effect only in such modified form or be of no effect, as the case may be; so, however, that any such modification or annulment shall be without prejudice to the validity of anything previously done under that rule.

35. If any difficulty arises in giving effect to the provisions of this Act, the Po Central Government may, by order, not inconsistent with the provisions of this cui Act, remove the difficulty:

Provided that no such order shall be made after the expiry of a period of two years from the appointed day.

Explanation.--In this Schedule, wherever any amount, specified in the fifth column against a coal mine, has been declared in the foot notes to include also the amount payable in relation to one or more other coal mines, all the coal mines in relation to which such amount has been specified in the said column as payable, shall be deemed, for the purposes of this Act, to constitute a group of coal mines.

STATEMENT OF OBJECTS AND REASONS

Coal is the most important indigenous source of commercial energy in India. It is available in adequate quantities in India, though much of it is poor in quality and the reserves are unevenly distributed among different regions of the country. With the nationalisation of 214 coking coal mines in Bengal-Bihar region, the development of metallurgical coal was brought under the control of the Government except in case of captive coal mines of the private steel plants. The non-coking coal mines, however, continued to remain in the hands of the private sector. These collieries were small in size, financially weak and worked on unscientific lines, the colliery owners' sole object being to earn quick profits without any regard to the conservation and safety of mines or to meet their obligation to the workers. This resulted in the stagnation of production in many collieries and closure of many others. It was envisaged that in order to meet the anticipated demand of coal in 1978-79 the private sector alone would have to contribute an additional quantity of 19 million tonnes requiring an investment of Rupees 100 crores, which was beyond the capacity of the private sector in the existing circumstances. Accordingly, it was decided to nationalise all the non-coking coal collieries.

As this process was likely to take some time, the Central Government took over, in the public interest, the management of the non-coking coal mines, pending nationalisation through promulgation of the Coal Mines (Taking Over of Management) Ordinance, 1973 (No. 1 of 1973) which has since been replaced by the Coal Mines (Taking Over of Management) Act, 1973 (No. 15 of 1973).

The present Bill seeks to complete the process of nationalisation of the coal mines by providing for the acquisition by the Central Government of the right, title and interest of the owners thereof.

FINANCIAL MEMORANDUM

Clause 8 of the Bill provides for the payment, in cash, by the Central Government, to the owners of the coal mines, an amount equal to the amount specified against each such mine or group of mines in the Schedule to the Bill, for vesting in the Central Government the right, title and interest of the owner in relation to such mine or group of mines. The total estimated amount involved on this account is likely to be of the order of Rs. 30.35 crores.

2. Sub-clause (1) of clause 9 of the Bill provides for the payment in cash, by the Central Government, to the owners of such mine a further amount equal to the amount which would have been, but for the retrospective operation of the provisions of clauses 3 and 5 of the Bill, payable to such owner under the Coal Mines (Taking Over of Management) Act, 1973 (No. 15 of 1973), for the period commencing on the 1st day of May, 1973, and ending on the day on which the Bill becomes an Act. The amount involved on this account is estimated at Rs. 7.50 lakhs per month.

3. Sub-clause (2) of clause 9 provides for the payment of simple interest on the amounts referred to in clause 8 at the rate of 4 per cent. per annum for the period commencing on the date o_n which the Bill becomes an Act and ending on the date on which payment of the said amounts is made to the Commissioner of Payments. It is estimated that the interest payments in terms of the provision of the said sub-clause are likely to be of the order of Rs. 10.12 lakhs per month.

4. Under clause 17 of the Bill, a Commissioner of Payments will be appointed by the Government, with adequate staff to assist him, for the purpose of disbursing the amounts payable to the owners of each noncoking coal mine. The salaries and allowances of the Commissioner of Fayments and his staff and expenditure on office and establishment will be defrayed out of the Consolidated Fund of India. The estimated expenditure on this account is likely to be of the order of Rs. 30,000 per month.

5. The Bill, if enacted, is not likely to involve any other recurring or non-recurring expenditure.

MEMORANDUM REGARDING DELEGATED LEGISLATION

Clause 34 of the Bill empowers the Central Government to make rules to carry out the provisions of the Bill. Such rules may provide for matters, such as—

(a) the manner in which the coal mines shall be managed by a Government company or a Custodian;

(b) the manner in which monies in any provident or other fund referred to in clause 15 shall be dealt with;

(c) the form and manner in which the statement of accounts referred to in clause 19 shall be prepared.

2. The matters in respect of which rules may be made are generally matters of procedure and administrative details and it is not practicable to provide for them in the Bill itself. The delegation of the legislative power is, therefore, of a normal character.
