It is proposed to take up for Construction of Pankena – Kankanoor road from Km 0/0 to 12.60 in Karimnagar District. The Government have accorded administrative sanction for an amount of Rs.23.50 Crores vide reference 1st cited.

The existing cart track starts at Pankena (via) Moded village is having a length of 11.60 Km which connects PR road and extends upto Singampalli (v) for 1.00 km on BT road pertains to PR Department towards Kankanoor (v). It is required to construct the road to all wheather road by proposing WMM and Bituminous concrete in addition to constructing C.D works, wherever necessary to have proper transportation facilities to the villagers.

The road is passing through two forest reaches from Km.0/200 to 3/629 and from Km.7/481 to 12/779 both sides. The above reaches are under the forest jurisdiction of Karimnagar East division.

The Telangana State Government have taken a policy decision to improve the interior roads to R&B standards. The Government have accorded administrative sanction for an amount of Rs.23.50 Crores, vide GO.Rt. No: 1 Dt: 02.01.2016. By improving the above road, further connectivity in terms of achieving smooth and safe traffic flow with higher level of service. In addition to the above, substantial economic gain in terms of reduced Vehicle Operating Cost (VOC) and reduced travel time will be achieved.

It is proposed to take up road construction for a length of 12.60 Km. As such the permission of the authorities is required. Hence, proposal is submitted for diversion of forest land workedout to an extent of 17.50 Hectares in Karimnagar East division.

A detailed differential Global Position Survey is carried out in the above reaches along with the forest section officers. As per our requirement the total extent of forest land is arrived as 17.50 Hectares in the jurisdiction of Karimnagar East Division.

The proposals are submitted as per the guide lines issued under Forest (Conservation) Act 1980, the project for road construction will be processed in their entirety. Hence, the proposals for acquisition of forest land is prepared in the Karimnagar East Forest Division, in the prescribed format, drawing showing the improvements, longitudinal section and cross section along with forest map showing the area of land are herewith enclosed for kind perusal. Hence, I herewith submit the proposals under Forest (Conservation) Act, 1980 with the following enclosures.

It is, therefore, requested to arrange to initiate the process of forest land acquisition and also required to pass necessary orders to the concerned to start the field survey as early as possible for submitting same to the Government for according approval of linear diversion of forest land for geometrical improvements of road in reserve forest.

The ROFR certificate issued by the District Collector along with the enclosures shall be obtained and furnished the DFO, Karimnagar East Division, for processing.
