With reference to Letter No.4681 dt.1.3.2019 of the Forest & Environment Department, Govt. of Odisha cited above, this is to inform you that Penalty for violation of forest land utilised for non-forestry purpose without F.C. clearance is to be deposited by the User Agency as required vide Condition No.2 (viii) of the Stage-I approval.




Sir,

I am directed to invite reference to your letter No. 3290 dt. 20.2.2019 on the above mentioned subject in which it was requested to issue clarification regarding time period to be taken into account for calculation of Penal NPV/simple interest for placing demand on the user agency by the DFO, Bonai as per stipulation made by ERO, MoEF&CC at point 2(viii) of their in-principle approval order dt.29.11.2018.

Having taken note of stipulation made at para 3(B)(i) of guidelines bearing F.No. 11-42/2017-FC dt. 29.1.2018 of MoEF&CC, GoI vis-à-vis the time period of violation involved in the instant case, it is clarified that the DFO, Bonai shall place demand with the user agency to pay five times of usual amount of NPV of forest land under this proposal as Penal NPV and rate of simple interest @ 12% is to be calculated on the penal NPV amount with effect from the date of expiry of the due date of deposit as per the demand order of DFO, Bonai.


The DFO, Bonai may be asked for compliance accordingly.


