









6. To present the documents for registration, if required by law, before the competent Registrar or Sub-registrar at the appropriate place or places to get the same duly registered.
7. To represent the Corporation in various excise matters before various excise authorities and to sign all documents in this regard.
8. To do all acts and deeds as may be necessary for and incidental to the execution and registration of such agreements/lease deeds.
9. To sign, verify, declare and execute written statements, counter claims, petitions, appeals, reviews, applications, affidavits and paper of every description that may be necessary to be signed, verified and executed for the purpose of any suit, actions, appeals, reviews, legal applications, criminal and civil proceedings of any kind whatsoever in any court of law or justice whether original, appellate or revisional jurisdiction.






