2. The area involved has been declared as a Reserved Forest vide Government of Gujarat Notification No. AKH-75-76/FLD-1175/61704-P, dated 10/02/1975.

3. 27670 trees are required to be cut in the demanded area. Girth and species wise list is attached herewith.

4. There is no violation of Forest (Conservation) Act, 1980 as Certified by the concerned Deputy Conservator of Forest.

5. The Project area is 105.00 Km. away from the Vansada National Park.

6. User Agency has submitted undertakings to defray the Cost of Compensatory Afforestation, Net Present Value and any increase thereof.

7. Compensatory Afforestation is proposed at 39.00 ha. Non forest land at Velavadar, Survey no.152pt9/p1 ,Ta. Bhavnagar, Dist.Bhavnagar. A scheme of Compensatory afforestation is attached herewith.

8. Site inspection report of the Project area is provided by the concerned Deputy Conservator of Forest.

In the circumstances explained in the above paragraphs and enclosures, the Government recommends that the said forest land may be allowed to be diverted for the non-forestry use under Section-2 of the Forest (Conservation) Act, 1980.
