

In compliance of the Ministry of Environment and Forest (MOEF), Government of India's letter No.11-9/98-FC dated 3rd August 2009 wherein the MOEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition for Forest Rights) Act. 2006 (FRA for short) on the forest land proposed to be diverted for non-forest purpose, read with MOEF's letter Dated 5 th February 2013 wherein MOEF issued certain relaxation in respect of linear projects, it is certified that 1.59 hectares of forest land propose to be diverted in favour of **Divisional Manager MPRDC for Construction of Tanda to Balwari Road** in Dhar District falls within jurisdiction of **Ghradi and Kolyabaari Village** in **Gandhwani Tehsils**.

- (a) The Complete process for identification and settlement of rights under the FRA has been carried out for the entire 1.59 Haq. of forest land proposed for diversion . A copy of records of all consultation and meetings of the Forest Rights Committee(s), Gram Sabha(s), Sub-Division Level Committee(s) and the District Level Committee(s) are enclosed as annexure 1 to 4 annexure
- (b) The diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the gram Sabhas have given their consent to it.
- (c) The proposal does not involve recognised rights of Primitive Tribal Groups and Pre-Agricultural Communities.
