Sub: Request for NoC for the establishment of Industrial Park at Therkuveerapandiyapuram & Silanatham villages of Ottapidaram Taluk and Meelavittan village of Thoothukudi Taluk in Thoothukudi District –Reg.

State Industries Promotion Corporation of Tamilnadu Ltd (SIPCOT) proposes to establish an Industrial Park over an extent of 631.108 hectares at Therkuveerapandiyapuram & Silanatham villages of Ottapidaram Taluk and Meelavittan village of Thoothukudi Taluk in Thoothukudi District.

We are now in the process of obtaining Environmental Clearance. The proposed Industrial Park is about 8.33 Km from Gulf of Mannar Marine National Park notified area. As per Wild Life Protection Act, 1972 for any projects which are developed above 5 Km and within 10 Km vicinity of Eco Sensitive Zone (ECZ), No Objection Certificate (NoC) from Wildlife Warden is required for the consideration of Environmental Clearance.

In this regard, we submit herewith the following documents required for obtaining NoC for the park:

- Undertaking that no projects are developed in the Protected Areas
- Analysis of Alternate Sites
- Biodiversity Report
- Justification document
- Topo map showing the distance of Gulf of Mannar Marine National Park from the project site
- Satellite image showing the distance of Gulf of Mannar Marine National Park from the project site.

We request that NoC may be issued at an early date to enable us submit our application to MoEF&CC.
