The Co-ordinates of the agreed PML area are in order.

The Checklist for Grant of "Golaghat District" PML is placed at Annexure - II and the justification for grant is given as under.

Total 3 exploratory wells, i.e. KH-27, SU-2 and UR-2 have been drilled in the area applied for PML. The status of reserves, OIIP: 97.87 MMBbl and Reserves:19.276 MMBbl. Production profile for Golaghat District PML, up to 20 years, as submitted by the operator is acceptable. The production profile and reserves may change in future, depending upon the production behavior of the producing wells.

It is, therefore, recommended that the grant of PML for "Golaghat District" measuring an area of 52.12 Sq. Km. to ONGC for a period of 20 years w.e.f. date of grant as per P&NG rules, may be agreed to.

In case, the production of oil/gas ceases permanently from the field during the period of grant, then ONGC need to keep DGH and Ministry informed.
