With reference to the subject cited above, I would like to inform you that the Chief Conservator of Forests & Nodal Officer, (F. C. Act) has informed to the undersigned vide his letter No. FG. 27/Nodal/Proposal/Jagiroad St. Qry. F (1)/Nagaon Divn., dtd. 29/05/2018 that the Govt. of India conveying "in principle approval" for diversion of 1.00 hect. of forest land in Sonaikuchi R. F. for operation of Jagiroad Stone Mahal No. F (1) under Western Range, Dharamtul of this Division, subject to the compliance of 10 (ten) Nos. stipulated conditions as enclosed herewith in the letter under reference.

So, you are requested to deposit the following Net Present Value (NPV) & Ad-hoc CAMPA Fund as estimated, which is shown below in details.

Code No. CORP0000371 separately & submit to the same report to the undersigned for onward submission to the authority concerned immediately. You are requested not to club two different proposal. We are aware that you have paid Rs. 4,35,912/- is excess against proposal of Jagiroad Stone Mahal No. F (2) dues proposal already shall be refunded or adjusted as the case may be.

It is also inform you that, formal transfer of forest land should not be affected till receipt of final approval order from the GOI against the project. You have failed to deposit the NPV etc. & any delay in payment shall result in cancellation of the in Principle Approval.
