Accordingly, the TSTDC has submitted Project proposals in FCA Format of Hyderabad Division with details, documentation and requisite undertakings from the Youth Advancement, Tourism & Culture Department (YAT&C) are submitted to the Principal Chief Conservator of Forest, (HoFF) for Forest Clearance for diversion of above mentioned land and requested to take necessary action for processing the proposal for permission.

Further, recognition of Forest Rights (RoFR) certificates in prescribed format (Form – II) on the forest area proposed for diversion shall also be obtained from the District Collector and submitted for processing.

After that, the forest department officials were examined the above proposals and advised to attend some rectifications and changes. In this regard, the proposals are rectified and resubmitted for Forest Clearance duly enclosing of Banker Cheque No.1807486, Dated:17.03.2016 for Rs.50,000/- in favour of "Joint Secretary, CEFNARM" towards user charges for verification of ETS & GNS data.

Hence, the Principal Chief Conservator of Forest, Hyderabad is requested to take necessary action for processing the proposal to sanction at an early date.
