Sir,

In inviting reference to the letter on the subject cited above, this is to inform you that, the Conservator of Forests (Central), Eastern Regional Office, Ministry of Environment, Forest and Climate Change, Government of India, Chandrasekharpur, Bhubaneswar have accorded in-principle (stage-1) approval for diversion of 12.274 ha of forest land under Baripada Forest Division, vide letter No.5-ORC 307/2017-BHU dt.04.08.2017.

As per item No. ii of the approval order, Net Present Value (NPV) of the forest area proposed to be diverted should be deposited by the User Agency as per the order of the Hon'ble Supreme Court of India, dt.28.03.2008 & dt.24.04.2008 in Writ Petition (C) No.202/1995. The density of the forest land is 0.5 and 0.1 in Reserve Forest and Revenue Forest respectively and Eco-class-III. So the NPV of the forest land comes to Rs.86,86,937/- (Rs.45,52,207/- for Reserve Forest and Rs.41,34,730/- for Revenue Forest) (Rupees Eighty six lakh eighty six thousand nine hundred thirty seven only).

You are requested to give an undertaking to the effect that, at the time of payment of Net Present Value (NPV) at present rate, the additional amount of NPV, if so determined as per the final decision of the Hon'ble Supreme Court of India will also be paid by you.



Further, you are requested to make payment of Rs.17,89,600/- (Rupees Seventeen lakh eighty nine thousand six hundred) only towards cost of Compensatory Afforestation Scheme over 6.07ha of village Daundia and Rs.4,34,73,000/- (Rupees four crore, thirty four lakh, seventy three thousand) only being the financial outlay for Catchment Area Treatment Plan (CATP) for the above project.


You are therefore, requested to make payment of the above amount through e-payment mode at an early date CAF, Odisha, Saving Bank Account No.SB01025222 in Corporation Bank, Lodhi Complex, Ground Floor, Block No.-II, CGO Complex, Phase-I, Lodhi Road, New Delhi-110003.






