In Compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No. 11-9/98-FC (pt.) dated 3<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that **0.725** hectares of forest land for Installation of **Nerli Group Water Supply Project** proposed to be diverted in favor of **Executive Engineer Public Health Engineering Project Jagdalpur, District Bastar Chhattishgarh** (name of user agency) for **Nerli Group Water Supply Project** (purpose for diversion of forest land) in **Dakshin Bastar Dantewada** district falls within the jurisdiction of **Ward Sabha of Municipal Council Bacheli, Gram Sabha of Kalepal, Samalwar Nerli Kuakonda, , in Bade Bacheli, Kuakonda** tehsil.

It is further certified that:

- (a) the complete process for identification and settlement of rights under the FRA has been carried out for the entire **0.725** hectares of forest area proposed for diversion for Installation of **Nerli Group Water Supply Project**. A copy of records of all consultations and meetings of the forest Rights Committee (s), Ward Sabha, Sub-Division Level Committee (s) and the district Level Committee are enclosed as annexure ..... to .....
- (b) the proposal for such diversion (with full details of the project and its implications in vernacular/ local language) have been placed before each concerned **Ward Sabha of Municipal Council Bacheli, Gram Sabha of Kalepal, Samalwar Nerli Kuakonda, , in Bade Bacheli, Kuakonda** of forests dwellers who are eligible under the FRA;
- (c) the each of concerned , Municipal Council (s), has certified that all formalities/ processes under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any having understood the purpose and details of proposed diversion. A copy of certificate issued by the **Ward Sabha of Municipal Council Bacheli, Gram Sabha of Kalepal, Samalwar Nerli Kuakonda, , in Bade Bacheli, Kuakonda** is enclosed as annexure ..... to .....
- (d) the discussion and decision on such proposals had taken pace only when there was a quorum of minimum 50% of the members of **Ward Sabha of Municipal Council Bacheli, Gram Sabha of Kalepal, Samalwar Nerli Kuakonda, , in Bade Bacheli, Kuakonda** present;
- (e) the diversion of forest land for facilities managed by the Government as required under section. 3(2) of the FRA have been completed and the **Ward Sabha of Municipal Council Bacheli, Gram Sabha of Kalepal, Samalwar Nerli Kuakonda, , in Bade Bacheli, Kuakonda** have given their consent to it;
- (f) the right of Primitive Tribal Groups and Pre-Agriculture Communities, where applicable have been specifically safeguarded as per section 3(1) (e) of the FRA.
