> Sub:- Rehabilitation and Up- gradation of newly declared NH- 752G Section from Satana to Mangrul (From Km. 64+000 to Km. 104+140) to two / four lane with paved shoulders in the state of Maharashtra on Engineering procurement & Construction (EPC) mode. (Unique proposal No.FP/MH/ROAD/151377/2022) Reg.Issuance of forest Rights Act (FRA) Certificate and Minimum Forest Land Demand Certificate

Sir,

The Ministry has declared Highway starting from its junction with NH-53 near Sendhwa connecting Khetia in the state of Madhya Pradesh, Shahada, Prakasha, Nandurbar. Visarwadi, Sakri, Satana, Deola, Chandvad, Manmad, Yeola, Kopargaon and terminating at its junction with NH-160 near Shirdi in the state of Maharashtra as National Highway No.752G, vide gazette notification no.13(E) dated-03.01.2017. Copy of the gazette enclosed herewith.

The work of DPR preparation of Rehabilitation and Up-gradation of Satana to Mangrul section of NH-752G (From Km. 64+000 to Km. 104+140) (Length-40.140 Km) to two lane/four lane with paved shoulders is in progress. The detailed survey has been conducted by DPR consultant and it is found that some length ('Bhabadbari Ghat & Kheldari Village) is passing through forest area and for rehabilitation and up-gradation of road (Curve improvement and widening) there is requirement of forest land. So, the forest land diversion proposal is being prepared.

It is submitted that, for Curve improvement and widening in the forest area, DPR consultant has considered minimum forest land.

In view of above, it is requested to issue Forest Right Act (FRA) certificate and Minimum Forest Land Demand certificate for forest land coming under subjected work. On receipt of this online submission of forest clearance proposal will be done.
