It is informed that, in the reference 1st cited, the Government of India have accorded Stage-I approval for diversion of 0.030 ha of Forest land in Gudlavanipalem Forest Block of Visakhapatnam Range & Division for construction of Dhobikana near Jodugullapalem (V) in favour of Executive Engineer, Greater Visakhapatnam Municipal Corporation, Visakhapatnam subject to certain conditions. It was communicated by the Prl.Chief Conservator of Forests A.P. Hyderabad in the reference 2nd cited (copies enclosed) for submission of compliance report point-wise as per the Stage-I approval accorded by the Government of India.

Hence the Executive Engineer, Greater Visakhapatnam Municipal Corporation, Visakhapatnam is requested to go through the conditions stipulated conditions i to xvi in the Gol, MoEF & CC, Regional Office, Chennai F.No.4-APB040/2017-CHN/1149, dt:24-07-2017 as per reference 1st cited and also follow the instructions issued by the Prl.Chief Conservator of Forests A.P. Guntur without any deviation and publish the entire forest clearances granted in verbatim along with the conditions in Telugu and English to make people awareness and also be submitted the copies to the Heads of local Bodies, Panchayats and Municipal Bodies by the project proponents of the G.O. copy to other relevant offices of the Government who inturn has to display the same in 30 days.

The user agency should pay the Net Present Value (NPV) Rs.0.13 lakh for the diverted forest land through online RTGS and furnish the receipt along with the compliance report on the conditions stipulated in the references cited point wise for onward submission to the Prl.Chief Conservator of Forests A.P. Guntur for further action in the matter.
