Subject: Proposal for diversion of 91.43 Ha, of forest land for construction of Imphal-Kangchup-Tamenglong Road Section.

Sir,

While enclosing herewith copy of letter F.No.3 MN C 035/2016-SHI/3194-95 dated 6.10.2016 (Annexure-1) from the Ministry of Environment Forest & Climate Change, North Eastern Regional office, Shillong on the above subject where the Ministry has conveyed the 'In Principle Approval' for diversion of 91.43 ha, of forest land for construction of Imphal-Kangchup-Tamengiong Road Section submitted by the PWD,Govt of Manipur under Forest (Conservation) Act. 1980 subject to 15 stipulated conditions. You are, therefore requested to comply with the stipulated conditions at an early date so that necessary working permission may be issued so as to enable the User Agency to start the work while processing for obtaining Stage-II approval of the project from the Ministry. Concerned DFOs should prepare the estimates under para (viii) & (ix) and submit to the Nodal Officer and User Agency after obtaining approval from the concerned CF/CCF.
